

## 1 Scope

The present document specifies the Abstract Test Suite (ATS) and partial Protocol Implementation eXtra Information for Testing (PIXIT) proforma for the Network side of the T reference point or coincident S and T reference point of implementations conforming to the stage three standard for the Explicit Call Transfer (ECT) supplementary service for the pan-European Integrated Services Digital Network (ISDN) by means of the Digital Subscriber Signalling System No. one (DSS1) protocol, EN 300 369-1 [1].

EN 300 369-5 [3] specifies the Test Suite Structure and Test Purposes (TSS&TP) related to this ATS and partial PIXIT proforma specification. Other parts specify the TSS&TP and the ATS and partial PIXIT proforma for the User side of the T reference point or coincident S and T reference point of implementations conforming to EN 300 369-1 [1].

## 4 Abstract Test Method (ATM)

### 4.1 Description of ATM used

The requirement for testing the network IUT is to focus on the behaviour of the network IUT at the user-network interface where a T reference point or coincident S and T reference point applies. Thus the IUT is the network DSS1 protocol entity at a particular user-network interface and is not the whole network.

In practice the behaviour at a single user-network interface does not occur in isolation, but depends on the activity at other user-network interfaces. Therefore a multi-party test method is used.




Figure 1: Multi-party test method

The general configuration used is shown in figure 1. In this ATS the PTCs act as slaves to the MTC; all active behaviour at the PTCs is initiated by CMs sent by the MTC and all verdicts are assigned by the MTC (using information sent in CMs by the PTCs where appropriate). Not all components are used in every test case and the relationship between the IUT and the tester depends on the test group.

#### 4.2 Served user test cases

For these test cases the IUT is connected to the MTC. Depending on the test case zero to three PTCs are used. The verdict depends only on the behaviour observed at the PCO between the IUT and the MTC. The PTC(s) are used only to provoke the IUT to send messages to the MTC or to handle behaviour at the remote user interface(s) as a result of activity at the IUT interface.

In general the correlation of messages between the served and remote user interfaces (which is part of the functionality of the supplementary service rather than the protocol) is not tested. If a message is expected at the MTC as a result of an action at a remote user and is not received this usually leads to an inconclusive verdict.

PTC3 is only used in certain test cases for the explicit linkage procedures.

#### 4.3 Remote user test cases

For these test cases the IUT is the protocol entity connected to either PTC1 or PTC2. The verdict is assigned by the MTC on the basis of behaviour reported in a CM by the PTC connected to the IUT and the behaviour of the served user attached to the MTC. A consequence of this is that incorrect behaviour by the served user can lead to a Fail verdict.

PTC3 is never used in the remote user test cases.

## 5 Untestable test purposes

There are no untestable test cases (see EN 300 369-5 [3]) associated with this ATS and ATM.

#### 6 ATS conventions

#### 6.1 Version of TTCN used

The version of TTCN used is that defined in TR 101 101 [5].

#### 6.2 Use of ASN.1

#### 6.2.1 Situations where ASN.1 is used

ASN.1 has been used for three major reasons. First, types defined in ASN.1 can model problems that "pure" TTCN cannot. For instance, data structures modelling ordered or unordered sequences of data are preferably defined in ASN.1. Second, ASN.1 provides a better restriction mechanism for type definitions by using sub-type definitions. Third, it is necessary to use ASN.1 to reproduce the type definitions for remote operation components as specified in the base standards in ASN.1.

The possibility to use TTCN and ASN.1 in combination is used, i.e. referring to an ASN.1 type from a TTCN type.

#### 6.2.2 Specification of encoding rules

There is a variation in the encoding rules applied to ASN.1 types and constraints specified in this ATS and therefore a mechanism is needed to differentiate the encoding rules. However the mechanism specified in ISO/IEC 9646-3 [7] and in TR 101 101 [5] does not facilitate definition of the encoding rules as needed for this ATS. A solution is therefore used which is broadly in the spirit of ISO/IEC 9646-3 [7] in which comment fields have been used as a means of encoding rules.

For ASN.1 used in this ATS, two variations of encoding rules are used. One is the commonly known Basic Encoding Rules (BER) as specified in ISO/IEC 8825-1 [6]. In the second case the encoding is according to ISDN, i.e. the ASN.1 data types are a representation of structures contained within the ISDN specification (basic call, generic functional protocol or individual supplementary service). For example, if octets of an information element are specified in ASN.1 as a SEQUENCE then this should be encoded in an Executable Test Suite (ETS) as any other ISDN information element specified using tabular TTCN. This ISDN encoding variation is the default encoding rule for this ATS. This means that all ASN.1 constraint tables are encoded using ISDN (non-BER) encoding unless stated otherwise. BER encoding shall not be applied to an ASN.1 constraint where BER encoding has not been specified. This encoding rule is sometimes named "Direct Encoding".

For BER encoding, an indication is given in the comments field of the table header. For this ATS such indications appear in the ASN.1 type constraint declaration tables only. In the first line of the table header comment field, the notation "ASN1\_Encoding: *BER*" is used.

Note that within BER, there are a number of variations for the encoding of lengths of fields. According to EN 300 196-1 [4], an IUT should be able to interpret all length forms within BER for received PDUs. When sending PDUs containing BER encoding, EN 300 196-1 [4] gives guidelines but makes no restrictions on the length forms within BER which an IUT may apply.

In this particular ATS all ASN.1 type constraints which are of type "Component" are to be encoded using BER.

## 7 ATS to TP map

The identifiers used for the TPs (see EN 300 369-5 [3]) are reused as test case names. Thus there is a straightforward one-to-one mapping.

#### 8 PCTR conformance

A test laboratory, when requested by a client to produce a PCTR, is required, as specified in ISO/IEC 9646-5 [7], to produce a PCTR conformant with the PCTR template given in annex B of ISO/IEC 9646-5 [7].

Furthermore, a test laboratory, offering testing for the ATS specification contained in annex C, when requested by a client to produce a PCTR, is required to produce a PCTR conformant with the PCTR proforma contained in annex A.

A PCTR which conforms to this PCTR proforma specification shall preserve the content and ordering of the clauses contained in annex A. Clause A.6 of the PCTR may contain additional columns. If included, these shall be placed to the right of the existing columns. Text in italics may be retained by the test laboratory.

#### 9 PIXIT conformance

A test realizer, producing an executable test suite for the ATS specification contained in annex C, is required, as specified in ISO/IEC 9646-4 [7], to produce an augmented partial PIXIT proforma conformant with this partial PIXIT proforma specification.

An augmented partial PIXIT proforma which conforms to this partial PIXIT proforma specification shall, as a minimum, have contents which are technically equivalent to annex B. The augmented partial PIXIT proforma may contain additional questions that need to be answered in order to prepare the Means Of Testing (MOT) for a particular IUT.

A test laboratory, offering testing for the ATS specification contained in annex C, is required, as specified in ISO/IEC 9646-5 [7], to further augment the augmented partial PIXIT proforma to produce a PIXIT proforma conformant with this partial PIXIT proforma specification.

A PIXIT proforma which conforms to this partial PIXIT proforma specification shall, as a minimum, have contents which are technically equivalent to annex B. The PIXIT proforma may contain additional questions that need to be answered in order to prepare the test laboratory for a particular IUT.

## 10 ATS conformance

The test realizer, producing MOT and ETS for this ATS specification, shall comply with the requirements of ISO/IEC 9646-4 [7]. In particular, these concern the realization of an ETS based on each ATS. The test realizer shall provide a statement of conformance of the MOT to this ATS specification.

An ETS which conforms to this ATS specification shall contain test groups and test cases which are technically equivalent to those contained in the ATS in annex C. All sequences of test events comprising an abstract test case shall be capable of being realized in the executable test case. Any further checking which the test system might be capable of performing is outside the scope of this ATS specification and shall not contribute to the verdict assignment for each test case.

Test laboratories running conformance test services using this ATS shall comply with ISO/IEC 9646-5 [7].

A test laboratory which claims to conform to this ATS specification shall use an MOT which conforms to this ATS.

## 11 Configurations required in testing

For some test cases it is necessary to configure the SUT in specific ways, this is described in table 2. In table 2 L0, L1 and L2 refer to the network interfaces connected to PCOs L0, L1 and L2 respectively. Except where specified otherwise the following configurations apply:

- for S/T reference point test cases (Groups ECT\_N01, ECT\_N02 and ECT\_N03):
  - L0 configured as S/T reference point;
  - L1 and L2 configured as S/T reference point for remote user tests (group ECT\_N03);
  - ECT subscribed at L0 as served user:
  - HOLD subscribed at L0 as served user; and
  - L1 and L2 supporting ECT and HOLD as remote users.
- for T reference point test cases (Groups ECT\_N04, ECT\_N05 and ECT\_N06):
  - L0 configured as T reference point;
  - L1 and L2 configured as T reference point for remote user tests (group ECT\_N06);
  - ECT subscribed at L0 as served user; and
  - L1 and L2 supporting ECT as remote users.

- New parameter L2\_INIT is needed. With this new parameter, it is possible to choose is layer 2 initialization needed or not.Requires changes also to test steps PR\_30001, PTC1\_PR00, PTC2\_PR00, PTC3\_PR00.
- PR30001, PTC1\_PR00, PTC2\_PR00, PTC3\_PR00 shall make use of the new PIXIT L2\_INIT
- Test cases ECT\_N05\_013, ECT\_N05\_014, ECT\_N05\_015: when a LinkId value is not assigned by the network
  and the ECT supplementary service is not subscribed to, IUT sends the error "notSubscribed" or
  "LinkIdnotAssignedByNetwork"
- Test cases ECT\_N06\_001, ECT\_N06\_002, ECT\_N06\_003, ECT\_N06\_004, ECT\_N06\_005, ECT\_N06\_006: TestGroup Network\_T/RemoteUserConnected (test cases ECT\_N06\_001, ECT\_N06\_002, ECT\_N06\_003, ECT\_N06\_004, ECT\_N06\_005, ECT\_N06\_006). Behaviour description is faulty in these test cases. In these test cases is used implicit ECT not explicit ECT. If test cases belongs to T-reference point it is needed to use Explicit ECT and Explicit ECT needs linkID value. If these test cases are used they should move to S/T\_network group or these test cases should be corrected to respond action of T reference point. Also in these test cases HOLD suppl.serv. is used and I think HOLD supplementary service does not apply at the T reference point according to EN 300 369-1 [1], clause 10.4. Test Step +ECT\_N\_PR\_001 (HOLD suppl. Serv.) should be removed. Also it is needed to add test step which handles getting linkID value from IUT (step ECT\_NP\_R\_012). Activation of ECT component is also needed to change from ECTexinv (implicit ECT) to ExpECTinv (Explicit ECT).
- Test cases ECT\_N05\_008: use step +PR301002(0) instead of +PR30102(0)
- PDU Constraint Declaration RL1: Cau element value is changed from ? to \*.This constrain is used in test cases ECT\_N05\_028, ECT\_N05\_036. In these test cases user A sends a DISCONNECT message with cause value 16. According to specification EN 300 403-1 table 3-10/Q.931 note 2 says "cause value is mandatory in the first call clearing message". According to this specification it is allowed to receive RELEASE message without cause value.

In addition, revisions including the update of the PIXIT were done.
