# Introduction

The present document covers TV band high performance Wireless Access Systems (WAS) including RLAN equipment which is used in wireless local area networks. Such networks provide high speed data communications in between devices connected to the wireless infrastructure. The present document also covers ad-hoc networking where devices communicate directly with each other, without the use of a wireless infrastructure.

The methods and principles used in the present document for the operation of TV White Space devices in the band 470 MHz to 694 MHz are taken from the ECC Report 186 [i.6], which explains the regulatory principles under which it is envisaged such devices will be permitted to operate in Europe. This approach is also explained in further detail in chapter 9 of "Dynamic White Space Spectrum Access" [i.12].

# 1 Scope

The present document specifies technical characteristics and methods of measurements for TV White Space Devices (TVWSDs) controlled by a TV White Space DataBase (TVWSDB) and which operate in the TV broadcast band 470 MHz to 694 MHz.

The present document applies to the following radio equipment categories:

- 1) Primary TV white space device.
- 2) Secondary TV white space device.

The present document applies to TVWSDs with integral, dedicated or external antennas, where TVWSDs using external antennas is covered only in the case of fixed use.

NOTE: The relationship between the present document and essential requirements of article 3.2 of Directive 2014/53/EU [i.3] is given in annex A.

# 3 Definition of terms, symbols and abbreviations

# 3.1 Terms

For the purposes of the present document, the terms given in ECC Report 159 [i.11], Directive 2014/53/EU [i.3] and the following apply:

**Adjacent Channel Leakage Ratio (ACLR):** ratio of the in-band transmit power measured in an 8 MHz TV channel, to the out-of-band emission measured in 100 kHz in an adjacent TV channel

altitude: height above the reference level defined by WGS84 [i.14]

**association:** process whereby a secondary TVWSD provides its device parameters to a primary TVWSD and initially identifies itself to its serving primary TVWSD

authentication: ability to verify the identity of a server, and that a message was truly sent by the primary TVWSD

**channel usage parameters:** parameters sent by a TVWSD to inform the TVWSDB of the actual radio resources that will be used by both the primary and the secondary TVWSDs

**dedicated antenna:** removable antenna supplied and assessed with the radio equipment, designed as an indispensable part of the equipment

device emission class: classification specified by the manufacturer that identifies the level of ACLR for the device

device parameters: parameters that specify the technical characteristics of an individual TVWSD, and its location

Digital Terrestrial Television (DTT): platform for the delivery of digital TV content via terrestrial broadcasting

DTT channel: 8 MHz channel in accordance with the European harmonised DTT channel raster

**external antenna:** removable antenna which is designed for use with a broad range of radio equipment and has not be designed for use with a specific product

NOTE: An external antenna is not assessed together with the equipment against the requirements of the present document.

**generic operational parameters:** transmission parameters communicated by a primary TVWSD to any secondary TVWSD within the coverage area of that primary TVWSD to allow the secondary TVWSD to operate as required

geographic validity: geographic area within which the operational parameters for a geo-located TVWSD are valid

**geo-location capability:** capability of a TVWSD to determine and report the latitude, longitude and altitude coordinates of its antenna

**geo-location uncertainty:** 3D position error defined by the difference in meters between the point reported by the TVWSD device to the TVWSDB and the actual position of the TVWSD antenna

**horizontal geo-location capability:** capability of a TVWSD to determine and report the latitude and longitude coordinates of its antenna

in-block emissions: intended emissions that fall within a single or multiple DTT channel(s)

**integral antenna:** antenna designed as a fixed part of the equipment, without the use of an external connector, which cannot be disconnected from the equipment by a user with the intent to connect another antenna

NOTE: An integral antenna may be fitted internally or externally. In the case where the antenna is external, a non-detachable cable can be used.

integrity: capability to protect messages against accidental or malicious changes during transit

out-of-block emissions: unwanted emissions that fall within the 470 MHz to 694 MHz band

Packet Error Rate (PER): number of incorrectly received data packets divided by the total number of received packets

**primary operational parameters:** transmission parameters communicated from a TVWSDB to a primary TVWSD to allow the primary TVWSD to operate as required

**primary TVWSD:** geo-located TVWSD that is able to access a TVWSDB through either a direct or an indirect connection to the Internet and to communicate with TVWSDs

regulatory domains: geographical area where a set of regulatory rules applies

NOTE: This is normally a country.

**reverse intermodulation attenuation:** measure of the capability of the transmitter to inhibit the generation of intermodulation signals in its non-linear components caused by the presence of the transmitter wanted signal and an unwanted signal reaching the transmitter via the antenna

**reverse intermodulation attenuation improvement:** measure of the improvement in reverse intermodulation attenuation beyond the minimum value required, as a function of in-block transmitter power

**secondary operational parameters:** transmission parameters communicated from a TVWSDB via a primary TVWSD to enable a secondary TVWSD to operate as required

**secondary TVWSD:** TVWSD that is only able to communicate with other TVWSDs, when under the control of a primary TVWSD

sleep mode: mode of operation for which the TVWSD is inactive but is not powered-down

**specific operation parameters:** transmission parameters communicated from a TVWSDB to a specific TVWSD (primary or secondary), taking account of the device parameters of that specific TVWSD

**test equipment:** equipment that provides the means to operate and control a UUT for the purposes of testing against the requirements contained in the present document

**test primary TVWSD:** test equipment that emulates the functionalities of a primary TVWSD for the purposes of testing a secondary TVWSD against the requirements contained in the present document

**test secondary TVWSD:** test equipment that emulates the functionalities of a secondary TVWSD for the purposes of testing a primary TVWSD against the requirements contained in the present document

# 4 Technical requirements specifications

# 4.1 Environmental profile

The technical requirements of the present document apply under the environmental profile for operation of the equipment, which shall be in accordance with its intended use. The equipment shall comply with all the technical requirements of the present document at all times when operating within the boundary limits of the operational environmental profile defined by its intended use.

# 4.2 Conformance requirements

# 4.2.1 Void

# 4.2.2 Equipment types

# 4.2.2.1 Definition

For the purpose of the present document, two equipment types have been defined with equipment Type A (clause 4.2.2.2) and equipment Type B (clause 4.2.2.3).

NOTE: It is envisaged that a TVWSD which is not fixed, will operate with an integral or dedicated antenna.

# 4.2.2.2 Equipment Type A

A Type A TVWSD is a device that is intended for fixed use only. This type of equipment can have integral, dedicated or external antennas.

## 4.2.2.3 Equipment Type B

A Type B TVWSD is a device that is not intended for fixed use and which has an integral antenna or a dedicated antenna.

# 4.2.3 Nominal Channel Bandwidth and Total Nominal Channel Bandwidth

# 4.2.3.1 Definitions

A Nominal Channel is defined as one or more contiguous DTT channels that are used by a TVWSD for its wanted transmissions.

The Total Nominal Channel Bandwidth is the sum of all of the Nominal Channel Bandwidths used simultaneously by a TVWSD.

A TVWSD may operate in a single DTT channel, or it may operate simultaneously in a group of contiguous DTT channels, multiple non-contiguous DTT channels, or a mixture of contiguous and non-contiguous DTT channels. See the examples in annex E.

# 4.2.3.2 Requirements

The Nominal Channel Bandwidth is a multiple of 8 MHz.

The lower and upper edge frequencies of a nominal channel shall coincide with the European harmonised DTT channel raster shown in figure 1.

The Nominal Channel Bandwidth used by a TVWSD shall not exceed the Maximum Nominal Channel Bandwidth specified by the TVWSDB (see clause 4.2.7.3.2.2).

The Total Nominal Channel Bandwidth used by a TVWSD shall not exceed the Maximum Total Nominal Channel Bandwidth specified by the TVWSDB (see clause 4.2.7.3.2.2).

NOTE: European harmonise DTT channel raster as per ITU GE06 regional agreement [i.15].

# 4.2.4 RF power and RF power spectral density

# 4.2.4.1 Definitions

## 4.2.4.1.1 RF power

The RF power is the mean Equivalent Isotropically Radiated Power (EIRP) averaged over the time period of a transmission burst.

# 4.2.4.1.2 RF power spectral density

The RF power spectral density is the mean Equivalent Isotropically Radiated Power (EIRP) over a bandwidth of 100 kHz and 8 MHz within a Nominal Channel (in-block) and averaged over the time period of a transmission burst.

## 4.2.4.2 Limits

The RF power and RF power spectral density radiated from a TVWSD shall not exceed the levels stated below irrespective of the number of transmit antennas:

- The RF power within DTT channel *i* shall not exceed the level P<sub>1,i</sub> dBm as specified by the TVWSDB for that channel.
- In the case of simultaneous operation in multiple DTT channels, the TVWSDB may direct a device to restrict its maximum total RF power as to min  $\{P_{1,i}\}$  dBm, where  $P_{1,i}$  is the RF power level specified by the TVWSD for DTT channel *i*. This restriction is communicated to the device by means of the simultaneous channel operation restriction parameter (see table 4). The RF power spectral density in any 100 kHz bandwidth within DTT channel *i* shall not exceed the level  $P_{0,i}$  dBm as specified by the TVWSDB for that channel.

# 4.2.4.3 Conformance

Conformance tests as defined in clause 5.4.2 and clause 5.4.3 shall be carried out.

# 4.2.5 Transmitter unwanted emissions

## 4.2.5.1 Transmitter unwanted emissions outside the 470 MHz to 694 MHz band

# 4.2.5.1.1 Definition

These are unwanted emissions from a TVWSD outside the 470 MHz to 694 MHz band when the TVWSD is in the transmit mode.

## 4.2.5.1.2 Limits

The level of these unwanted emissions shall not exceed the limits given in table 1. These limits apply to the overall emissions of a TVWSD and in any possible configuration.

In case of equipment with antenna connectors, these limits apply to emissions at the antenna port (conducted) and to the emissions radiated by the cabinet. In case of integral antenna equipment (without temporary antenna connectors), these limits apply to emissions radiated by the equipment.

## 4.2.5.1.3 Conformance

Conformance tests as defined in clause 5.4.4 shall be carried out.

## 4.2.5.2 Transmitter unwanted emissions within the 470 MHz to 694 MHz band

#### 4.2.5.2.1 Definition

These are unwanted emissions from a TVWSD outside the nominal channels (out-of-block) within the 470 MHz to 694 MHz band when the TVWSD is in the transmit mode.

## 4.2.5.2.2 Limits

The out-of-block EIRP spectral density, P<sub>OOB</sub>, of a TVWSD shall satisfy the following limit:

$$P_{OOB}\left(dBm \,/\, (100 \text{ kHz}) \leq max\{\ P_{IB}\left(dBm \,/\, (8 \text{ MHz}) - ACLR\left(dB\right), -84 \left(dBm \,/\, (100 \text{ kHz})\right.\}\right)$$

where  $P_{IB}$  is the measured in-block EIRP spectral density over 8 MHz, and ACLR is the adjacent channel leakage ratio outlined in the table 2 for different Device Emission Classes.

Each out-of-block EIRP spectral density is examined in relation to  $P_{IB}$  in the nearest (in frequency) DTT channel used by the TVWSD. Where there are two nearest (in frequency) DTT channels used, the one with the lower  $P_{IB}$  shall be considered.

The manufacturer shall declare which Device Emission Class from table 2 that the TVWSD complies with.

#### 4.2.5.2.3 Conformance

Conformance tests as defined in clause 5.4.3 shall be carried out.

# 4.2.6 Transmitter Reverse Intermodulation Attenuation

## 4.2.6.1 Definition

The transmitter intermodulation attenuation is a measure of the capability of a transmitter to inhibit the generation of signals in its non-linear elements caused by the presence of the transmitter power and an interfering signal entering the transmitter via its antenna.

## 4.2.6.2 Limits

The level of the wanted signal shall be the maximum power that the device can support  $(P_{IBMax} (dBm))$ .

In the presence of an unwanted signal as described below:

- a) The level of the unwanted signal shall be 40 dB below  $P_{IBMax}$  (dBm).
- b) The unwanted signal shall be a continuous wave.
- c) The centre frequency of the unwanted signal  $(f_{un})$  shall be offset at  $\pm$  8 MHz from the wanted signal centre frequency  $(f_{w})$ .
- d) Unwanted signals which are partially or completely outside the band 470 MHz to 694 MHz are excluded.

The third-order reverse intermodulation attenuation (RIM3) is defined (in decibels) as RIM3( $P_{IB}$ ) =  $(2 \times P_{IB}) + P_u$  - PIM3( $P_{IB}$ ) where:

- $P_{IB} = Mean in block power (dBm).$
- P<sub>IBMax</sub> = Maximum in block power (dBm) that the device can support.
- $P_u$  = Power of the unwanted signal (dBm) which should be set to 40 dB below the maximum power that the device can support ( $P_{IBMax}$  (dBm)).
- PIM3 = Power (dBm) of the third order intermodulation product at frequency (2 × f<sub>w</sub> f<sub>un</sub>), measured in a 100 kHz bandwidth.

The device shall have a Reverse InterModulation attenuation (RIM3) greater than 45 dB.

## 4.2.6.3 Conformance

Conformance tests as defined in clause 5.4.5 shall be carried out.

# 4.2.7 Control and monitoring

# 4.2.7.1 Control and monitoring mechanisms

Control and monitoring mechanisms shall:

- prevent a primary TVWSD from transmitting in the absence of communications with an approved TVWSDB;
- prevent a secondary TVWSD from transmitting in the absence of communications with a primary TVWSD;
- require a primary TVWSD or a secondary TVWSD to transmit in accordance with instructions and parameters provided by approved TVWSDBs;

• prevent a primary TVWSD from getting parameters from an TVWSDB that is not approved by the relevant national authority.

NOTE: The protocols used for data transfer between secondary TVWSDs, primary TVWSDs and TVWSDB are outside the scope of the present document.

## 4.2.7.2 TVWSDB identification

## 4.2.7.2.1 Applicability

These requirements apply to a Primary TVWSD only.

#### 4.2.7.2.2 Definition

TVWSDB identification is the process by which the primary TVWSD identifies the weblisting of approved TVWSDB(s), and only contacts a TVWSDB which is in that weblisting.

## 4.2.7.2.3 Requirements

At start up and before initiating any transmissions within the 470 MHz to 694 MHz band the primary TVWSD shall identify and consult the weblisting. The primary TVWSD shall not transmit within the 470 MHz to 694 MHz band if it cannot consult the weblisting.

The primary TVWSD shall also reconsult this weblisting after no more than N minutes. The value N will be specified in the same weblisting as the approved TVWSDBs.

A primary TVWSD shall not request operational parameters from (i.e. query) a TVWSDB that is not on the weblisting that corresponds to its geographical location.

NOTE: A list of these weblistings is given in ETSI TR 103 231 [i.10].

If the weblisting is not accessible after the time specified by N has expired, the TVWSD shall:

- a) continue to use the weblisting that it already holds; and
- b) try to reconsult the weblisting at least as frequently as once every two hours thereafter but not more frequently than once per hour until such time as when the weblisting can be accessed.

# 4.2.7.2.4 Conformance

Conformance tests as defined in clause 5.4.14.1 shall be carried out.

# 4.2.7.3 Data exchange and compliance with parameters

# 4.2.7.3.1 Applicability

These requirements do not apply to secondary devices which are receive only in the 470 MHz to 694 MHz band.

## 4.2.7.3.2 Device parameters, operational parameters and channel usage

#### 4.2.7.3.2.1 Device Parameters

These are the device parameters for either the primary TVWSD or the secondary TVWSD and are listed in table 3. The device parameters of a primary TVWSD are communicated from the primary TVWSD to the TVWSDB. The device parameters of a secondary TVWSD are communicated from the secondary TVWSD to the serving primary TVWSD, which will then communicate these to the TVWSDB.

# 4.2.7.3.2.2 Operational Parameters

The operational parameters in table 4 are used by any TVWSD in order to configure its transmissions within the 470 MHz to 694 MHz band. All operational parameters are generated by the TVWSDB and communicated to the primary TVWSD. Operational parameters for secondary TVWSDs from the TVWSDB are communicated via the serving primary TVWSD. The operational parameters may be communicated to the secondary TVWSD by the primary TVWSD as either as a single set of parameters or a series of sets of parameters.

Specific operational parameters are operational parameters that a TVWSDB calculates using the device parameters of a specific TVWSD as input. A TVWSDB will only provide specific operational parameters for a TVWSD if it has received the device parameters of that TVWSD.

Generic operational parameters are the operational parameters that any secondary TVWSD in the coverage area of a serving primary TVWSD can use. A TVWSDB will provide generic operational parameters to a primary TVWSD, and the primary will broadcast these parameters for all secondary TVWSDs in its coverage area. The TVWSDB will calculate generic operational parameters using, as input, the device parameters of the primary TVWSD and a set of assumptions about the secondary TVWSDs.

NOTE: The algorithms to calculate operational parameters and the assumptions for these calculations are outside the scope of the present document.

# 4.2.7.3.2.3 Channel Usage Parameters

The Channel Usage Parameters in table 5 describe the radio resources (frequencies and powers) that a TVWSD intends to use. These radio resources may be the full set or a subset of the resources indicated by the TVWSDB in the Operational Parameters.

The Channel usage parameters are communicated from a primary TVWSD to the TVWSDB, or from a secondary TVWSD to its serving primary TVWSD which it will forward to the TVWSDB.

The operational parameter  $P_{0,i}$  is the peak EIRP value in dBm that shall not be exceeded in *any* 100 kHz bandwidth within channel i.

The channel usage parameter  $p_{0,i}$  is the peak EIRP value in dBm that the TVWSD shall not exceed in *any* 100 kHz bandwidth within channel *i*.

#### 4.2.7.3.3 Transmission in compliance with parameters

#### 4.2.7.3.3.1 Definitions

#### **Operational parameters**

A TVWSD is considered to be transmitting in accordance with a set of operational parameters if all of the (below) listed operational parameters are being complied with:

- The TVWSD only transmits in DTT channels that are in the list of available channels provided by the relevant TVWSDB.
- The TVWSD RF EIRP in each DTT channel does not exceed the maximum specified by the relevant TVWSDB.
- The TVWSD RF EIRP spectral density in each DTT channel does not exceed the maximum EIRP spectral density specified by the relevant TVWSDB.
- The Nominal Channel Bandwidth of each TVWSD nominal channel does not exceed the Maximum Nominal Channel Bandwidth specified by the relevant TVWSDB.
- The Total Nominal Channel Bandwidth used by the TVWSD does not exceed the Maximum Total Nominal Channel Bandwidth specified by the relevant TVWSDB.
- The TVWSD transmission time is between the time validity start (T<sub>ValStart</sub>) and the time validity end (T<sub>ValEnd</sub>) specified by the relevant TVWSDB.
- The estimated TVWSD location is less than L<sub>Val</sub> away from the location reported to the TVWSDB at the time the operational parameters were obtained from the relevant TVWSDB.

#### Channel usage parameters

A TVWSD is considered to be transmitting in accordance with the set of channel usage parameters if:

- The TVWSD only transmits in DTT channels that are in the list of channels described by the said channel usage parameters.
- The RF EIRP in each DTT channel does not exceed the intended level specified in the channel usage parameters.
- The RF EIRP spectral density in each DTT channel does not exceed the intended level specified in the channel usage parameters.

#### 4.2.7.3.3.2 Requirements

A primary TVWSD shall not start transmissions in the UHF TV band unless it has received operational parameters from a TVWSDB.

A secondary TVWSD shall not start transmissions in the UHF TV band unless it has received operational parameters, either generic or specific, from a primary TVWSD.

A primary TVWSD shall, at any point in time, only transmit in accordance with operational parameters that it has received from a TVWSDB.

A secondary TVWSD shall, at any point in time, only transmit in accordance with specific or generic operational parameters received from a primary TVWSD.

A primary TVWSD shall, at any point in time, only transmit in accordance with the channel usage parameters that it has communicated to a TVWSDB.

If a secondary TVWSD's usage parameters have been communicated to the TVWSDB, then the secondary TVWSD shall transmit in accordance with the said channel usage parameters.

Communication between two secondary devices is permitted providing that each of the secondary TVWSDs is operating in accordance with the operational parameters given by its serving primary TVWSD.

## 4.2.7.3.4 Reporting of device parameters

#### 4.2.7.3.4.1 Definitions

These requirements apply to:

- A primary TVWSD that requires operational parameters.
- A secondary TVWSD that requires specific operational parameters, or that intends to use the generic operational parameters broadcasted by a primary TVWSD.

The reporting of device parameters is understood as the communication from the TVWSD to the TVWSDB containing one or more of the parameters in table 3.

# 4.2.7.3.4.2 Requirements

A primary TVWSD that requires operational parameters from a TVWSDB shall first accurately report its own device parameters to the TVWSDB. Apart from the location, these device parameters shall be specified by the manufacturer (see clause 5.4.1).

A secondary TVWSD that requires specific operational parameters shall accurately report its own device parameters to the serving primary TVWSD.

A secondary TVWSD that intends to use the generic operational parameters broadcasted by a primary shall accurately report its unique device identifier to the serving primary. The secondary TVWSD may also report its other device parameters.

If any of the parameters shown in table 3 cannot be reported to the TVWSDB then the device shall indicate that the parameter is not available.

# 4.2.7.3.5 Reporting of channel usage parameters

## 4.2.7.3.5.1 Definition

The reporting of channel usage parameters is understood as the communication from the TVWSD to the TVWSDB containing the parameters in table 5.

#### 4.2.7.3.5.2 Requirements

A primary TVWSD shall communicate its channel usage parameters to the TVWSDB prior to transmission.

A secondary TVWSD shall communicate its channel usage parameters to its serving primary TVWSDB, unless the secondary TVWSD channel usage parameters have been chosen by the primary TVWSD.

If a device frequency hops among DTT channels, then the channel usage parameters shall include the full list of DTT channels it intends to hop into, as well as the in-block EIRP and the EIRP spectral density it intends to use in each channel.

## 4.2.7.3.6 Functionality of a primary TVWSD to support secondary TVWSDs

# 4.2.7.3.6.1 Applicability

A secondary TVWSD receives operational parameters through a primary TVWSD, and not directly from a TVWSDB. The requirements in this clause relate to:

• the communication of the information that the primary TVWSD receives from a TVWSDB and that is intended for one or all the associated secondary TVWSDs; and

• the communication of the information that the primary TVWSD receives from any associated secondary TVWSD that is intended for the TVWSDB.

A primary TVWSD may be able to broadcast generic operational parameters, which can be used by secondary TVWSDs in the primary's coverage area.

A primary TVWSD may be able to support provision of specific operational parameters to secondary TVWSDs in its coverage area.

#### 4.2.7.3.6.2 Definitions

A subset of an initial set of operational parameters is defined as a set of operational parameters such that:

- It contains all or some of the DTT channels in the initial set.
- The maximum in-block RF EIRP spectral density in each DTT does not exceed the corresponding value in the initial set.
- The maximum in-block RF EIRP in each DTT channel does not exceed the corresponding value in the initial set.
- The maximum nominal channel bandwidth does not exceed the corresponding value in the initial set.
- The maximum total bandwidth does not exceed the corresponding value in the initial set.
- The time validity is equal to, or contained within, the time validity in the initial set.
- The location validity is equal or smaller than the location validity in the initial set.

#### 4.2.7.3.6.3 Requirements

A primary TVWSD that supports broadcast of generic operational parameters shall:

- report its device parameters to the TVWSDB in order to obtain said generic operational parameters;
- broadcast generic operational parameters that are equal to, or a subset of, those received from the TVWSDB;
- report to the TVWSDB its own Unique ID together with the device parameters of the secondary TVWSD(s) which transmit using the generic operational parameters.

NOTE: Some secondary TVWSDs may only report their Unique Device Identifier.

A primary TVWSD that supports provision of specific operational parameters to the secondary TVWSDs in its coverage area shall:

- provide to the TVWSDB the device parameters of the secondary TVWSDs for which it is requesting specific operational parameters;
- provide to each secondary TVWSD specific operational parameters that are equal to, or a subset of, those received from the TVWSDB for that secondary TVWSD.

A primary TVWSD shall accurately communicate to the TVWSDB its own Unique ID together with the channel usage parameters that it may receive from its served secondary TVWSDs.

# 4.2.7.3.7 Conformance

Conformance with the requirements in clause 4.2.7.3.1 to clause 4.2.7.3.6 shall be tested according to clause 5.4.14.2.

# 4.2.7.4 Primary TVWSD update

# 4.2.7.4.1 Definition

The primary TVWSD update is the process by which a TVWSDB informs a primary TVWSD that its operational parameters, and those of the secondary TVWSDs attached to it, are still valid or are no longer valid. The update can be initiated by either the primary TVWSD or the TVWSDB.

# 4.2.7.4.2 Requirements

A primary TVWSD shall support TVWSD update function.

A primary TVWSD shall cease transmission, and shall instruct the secondaries attached to it to cease transmission, if it receives update from the TVWSDB that the operational parameters are no longer valid.

A primary TVWSD shall cease transmission, and shall instruct the secondaries attached to it to cease transmission, if it fails to connect with the TVWSDB for a period which exceeds  $T_{Update}$ . The parameter  $T_{Update}$  is itself one of the operational parameters (see clause 4.2.7.3.2.2).

A primary TVWSD shall update every T<sub>Update</sub>.

A primary TVWSD shall support a  $T_{\mbox{Update}}$  value of 60 seconds or greater.

A TVWSD is allowed to enter a sleep mode, i.e. inactive but not powered down. A primary device that is in sleep mode, does not need to be reachable by the TVWSDB, and does not need to contact the TVWSDB, while it remains in sleep mode.

A primary TVWSD which has been in sleep mode for longer than  $T_{Update}$  and wants to restart transmissions shall not transmit according operational parameters obtained before going into sleep mode until it has been updated by the TVWSDB that the operational parameters are still valid.

#### 4.2.7.4.3 Conformance

Conformance with the requirements in clause 4.2.7.4.2 shall be tested according to clause 5.4.6 and clause 5.4.7.

# 4.2.7.5 Secondary TVWSD update

## 4.2.7.5.1 Applicability

These requirements do not apply to secondary devices which are receive only in the 470 MHz to 694 MHz band.

## 4.2.7.5.2 Definition

The secondary TVWSD update is the process by which a primary TVWSD informs a secondary TVWSD that its operational parameters are still valid or are no longer valid.

# 4.2.7.5.3 Requirements

A secondary TVWSD shall support TVWSD update function.

A secondary TVWSD shall cease transmission when the primary informs the secondary TVWSD that its operational parameters are no longer valid.

A secondary shall cease transmission within five seconds of discovering that it can no longer receive updates from its serving primary TVWSD.

A TVWSD is allowed to enter a sleep mode, i.e. inactive but not powered down. A secondary device that is in sleep mode, does not need to be reachable by the primary device, and does not need to contact the primary device, while it remains in sleep mode.

A secondary TVWSD which has been in sleep mode for more than five seconds and wants to restart transmissions shall re-confirm its operational parameters with the serving primary TVWSD before continuing transmissions.

#### 4.2.7.5.4 Conformance

Conformance tests as defined in clause 5.4.8 and clause 5.4.9 shall be carried out.

# 4.2.8 Receiver Sensitivity Level

# 4.2.8.1 Applicability

This requirement applies to all types of equipment.

#### 4.2.8.2 Definition

The receiver sensitivity level is the minimum mean power received at the UE at which the performance criteria defined in clause 4.2.8.3 is met.

## 4.2.8.3 Performance Criteria

The minimum performance criteria shall be a PER less than or equal to 10 %.

## 4.2.8.4 Limits

The measured sensitivity level shall not exceed -65 dBm.

#### 4.2.8.5 Conformance

Conformance tests described in clause 5.4.10 shall be carried out.

# 4.2.9 Adjacent Channel Selectivity

# 4.2.9.1 Applicability

The present requirement applies to all equipment within the scope of the present document.

## 4.2.9.2 Definition

Adjacent channel selectivity is a measure of the capability of the equipment to receive a wanted signal on its Operating Channel without exceeding a given degradation due to the presence of an adjacent channel interfering signal at a given offset from the Nominal Centre Frequency (fc) of the Operating Channel.

# 4.2.9.3 Performance Criteria

The minimum performance criteria shall be a PER less than or equal to  $10\,\%$ .

# 4.2.9.4 Limits

The limits defined below apply when the equipment operates on a single 8 MHz Operating Channel and the Occupied Channel Bandwidth of the interfering signal falls completely within a 8 MHz channel adjacent to the Operating Channel.

While maintaining the minimum performance criteria as defined in clause 4.2.9.3, the adjacent channel interferer level shall be equal to or greater than the limit defined in table 6 at the specified ranges of frequency offsets.

**Table 6: Adjacent Channel Selectivity parameters**

NOTE 1: P<sub>min</sub> is the minimum level of the wanted signal (in dBm) required to meet the minimum performance criteria as defined clause 4.2.9.3 in the absence of any interfering signal.

NOTE 2: The levels specified are levels in front of the UUT antenna. In case of conducted measurements, the same levels should be used at the antenna connector irrespective of antenna gain.

## 4.2.9.5 Conformance

Conformance tests described in clause 5.4.11 shall be carried out.

# 4.2.10 Receiver Blocking

# 4.2.10.1 Applicability

This requirement applies to all types of equipment.

## 4.2.10.2 Definition

Receiver blocking is a measure of the equipment ability to receive a wanted signal on its operating channel in the presence of an unwanted signal (blocking signal) on frequencies other than those of the operating band.

# 4.2.10.3 Performance Criteria

The minimum performance criteria shall be a PER less than or equal to 10 %.

#### 4.2.10.4 Limits

While maintaining the minimum performance criteria as defined in clause 4.2.8.3, the blocking levels at specified frequency offsets shall be equal to or greater than the limits defined in table 7.

NOTE: P<sub>min</sub> is the minimum level of the wanted signal (in dBm) required to meet the minimum performance criteria as defined clause 4.2.8.3 in the absence of any blocking signal.

# 4.2.10.5 Conformance

Conformance tests as defined in clause 5.4.12 shall be carried out.

# 4.2.11 Receiver spurious emissions

# 4.2.11.1 Definition

These are unwanted RF emissions from a TVWSD at any frequency when the equipment is in receive mode.

#### 4.2.11.2 Limits

The level of the receiver spurious emissions from a TVWSD shall not exceed the limits given in table 8.

In case of equipment with antenna connectors, these limits apply to emissions at the antenna port (conducted) and to the emissions radiated by the cabinet. In case of integral antenna equipment (without temporary antenna connectors), these limits apply to emissions radiated by the equipment.

# 4.2.11.3 Conformance

Conformance tests as defined in clause 5.4.13 shall be carried out.

# 4.2.12 Geo-Location capability

#### 4.2.12.1 Definition

Geo-location capability is the capability of a TVWSD to determine and report the latitude and longitude (i.e. horizontal geo-location capability) and altitude (i.e. vertical geo-location capability) coordinates of its antenna.

# 4.2.12.2 Requirements

A primary TVWSD shall have a horizontal geo-location capability.

A secondary TVWSD may have a horizontal geo-location capability.

A TVWSD with a horizontal geo-location capability may also have a vertical geo-location capability.

A TVWSD which has geo-location capability and is able to determine its location shall:

- 1) report the geo-location coordinates of its transmit antenna(s), as part of its device parameters; and
- 2) report its geo-location uncertainty (in meters), with a confidence level of 95 %, as part of its device parameters.

A Type B TVWSD that has geo-location capability shall confirm its location at least every 60 seconds except while in sleep mode.

A Type B TVWSD that has geo-location capability, has been in sleep mode, and wants to restart transmissions shall confirm its location before transmitting.

A TVWSD, whose location is more than  $L_{Val}$  away from the location reported to the TVWSDB, shall not transmit according to the operational parameters for the reported location.

NOTE:  $L_{Val}$  is part of the set of operational parameters, and it is recognized that there is a permitted geo-location uncertainty.

A TVWSD which had previously reported a location to the TVWSDB but it is no longer able to determine its location shall stop transmitting in accordance with the existing operational parameters.

A TVWSD which does not have horizontal geo-location capability, or does have horizontal geo-location capability but is not currently able to determine its location, shall indicate to the TVWSDB that horizontal geo-location is not available.

A TVWSD which does not have vertical geo-location capability, or does have vertical geo-location capability but is not currently able to determine its location, shall indicate to the TVWSDB that vertical geo-location is not available.

#### 4.2.12.3 Conformance

Conformance tests as defined in clause 5.4.15 shall be carried out.

# 4.2.13 User Access Restrictions

# 4.2.13.1 Definition / General

As certain parameters are deemed to be critical in the mitigation of interference to other users, the parameters listed in clause 4.2.13.2 are subject to User Access Restrictions.

User Access Restrictions are intended to ensure that the defined value or range of values, settings and functions for the identified parameters cannot be altered by any software or hardware element in the field by the user to any value that falls outside of the range of values detailed in the appropriate clauses within the present document.

NOTE: The user should be understood as to include the end user, the operator or any person not responsible for the compliance of the equipment against the requirements in the present document.

In addition, any hardware element that can be activated by the user to change the identified parameters in clause 4.2.13.2 is also subject to the requirements of this clause.

# 4.2.13.2 Parameters subject to User Access Restrictions

The following parameters are subject to user access restrictions described in clause 4.2.13.1:

- i) The equipment shall not allow the user to have access to settings (hardware and/or software) that relate to the exchange of the parameters given in table 3, table 4 and table 5, communicated between a TVWSD and a TVWSDB.
- ii) The equipment shall not allow the user to have access to settings (hardware and/or software) that relate to the TVWSDB identification (see clause 4.2.7.2).

## 4.2.13.3 Conformance

The UUT shall be deemed to comply with the requirements of the present document if the UUT does not provide options that allow automatic or manual adjustment of limits and/or requirements for those parameters identified in clause 4.2.13.2.

The conformance verification procedure for this requirement is defined in clause 5.4.16.

# 5 Testing for compliance with technical requirements

# 5.1 Introduction

The testing of device compliance with the technical specifications of clause 4 is described in this clause.

# 5.2 Conditions for testing

# 5.2.1 Normal and extreme test conditions

Unless otherwise stated in the test procedures for essential radio test suites (clause 5.4), the tests defined in the present document shall be carried out at representative points within the boundary limits of the specified normal and extreme test conditions (see clause 5.4.1, item r)).

Where technical performance varies subject to environmental conditions, tests shall be carried out under a sufficient variety of environmental conditions (within the boundary limits of the specified normal and extreme test conditions) to give confidence of compliance for the affected technical requirements.

# 5.2.2 Antennas

Equipment using integral antennas may be provided with temporary connectors for purposes of testing.

An antenna assembly referred to in the present document is understood as the combination of the antenna, its coaxial cable and, if applicable, its antenna connector and associated switching components. The gain of an antenna assembly, G in dBi, does not include the additional gain that may result from beamforming.

Multiple antenna systems may use beamforming techniques which may result in additional (antenna) gain. This beamforming gain (Y) is specified in dB. Beamforming gain does not include the gain of the antenna assembly (G), or the gain resulting from adding the transmit powers from the antennas.

For a UUT with antenna connector(s) provided, conducted measurements shall be performed.

For a UUT with integral antenna(s) and without a temporary antenna connector(s), radiated measurements shall be used.

When performing radiated measurements, the UUT shall be configured and antenna(s) positioned (including smart antenna systems and systems capable of beamforming) for maximum EIRP towards the measuring antenna.

For radiated measurement, the relevant test procedure with the test set-up as described in annex B and the applicable measurement procedures as described in annex C shall be used.

# 5.2.3 Conducted measurements, radiated measurements, and relative measurements

Unless otherwise specified, either conducted or radiated measurements may be used.

For integral antenna equipment, connectors may be provided to allow conducted measurements to be performed.

In the case of integral antenna equipment that has no antenna connector(s), the manufacturer may be required to supply a test fixture, to allow relative and normalized measurements to be made.

The test fixture and its use are further described in clause B.4.

# 5.2.4 Transmit operating modes

#### **Operating mode 1 (single antenna)**

The equipment uses only one antenna when operating in this mode.

The following types of equipment and/or operating modes are examples covered by this category:

- Equipment with only one antenna.
- Equipment with two or more diversity antennas, but where at any moment in time only one antenna is used for transmission.
- Equipment with two or more antennas, but operating in a mode where only one antenna is used.

#### Operating mode 2 (multiple antennas, no beamforming)

The equipment that operates in this mode transmits simultaneously from multiple antennas but without beamforming.

#### Operating mode 3 (multiple antennas, with beamforming)

The equipment that operates in this mode transmits simultaneously from multiple antennas with beamforming.

In addition to the antenna assembly gain, G, the beamforming gain, Y, shall have to be taken into account when performing the measurements described in the present document.

# 5.2.5 Requirements for the test modulation

The modulation/multiple-access scheme used by the UUT for the purposes of testing shall be representative of normal use of the equipment. Where the equipment is not capable of continuous RF transmission, the test modulation/multiple-access scheme shall be such that transmissions occur regularly in time.

If the equipment uses multiple modulation methods with different RF characteristics, the modulation that produces the worst measured values (values which comply with the limits by the smallest margin) for each essential test shall be used, and this modulation shall be specified along with the rationale for why this modulation produces worse values than other modulation methods used by the equipment.

# 5.2.6 Communication between test TVWSDB, primary and secondary UUT

For the purpose of the tests defined in the essential test suites, a primary UUT shall be connected to an appropriate test set-up (which incorporates a test TVWSDB) using a non-radio link. The TE shall be configured to allow a primary UUT or primary test TVWSD to readily identify (or otherwise consult) its test TVWSDB upon connection.

The primary UUT shall be configured to operate with an appropriate TE (test TVWSDB).

The communication protocol between the secondary TVWSD and the primary TVWSD will be defined by the radio technology specifications of the TVWSDs being tested.




Figure 2: Test set-up

The above are illustrated in figure 2.

# 5.2.7 Operational Parameter set

The operational parameters shall be set as follows:

The channel edge frequency shall fall within the operational frequency range provided by WSDB.

- The value for the maximum mean in-block EIRP spectral densities shall be equal or smaller than the values of the maximum permitted mean in-block EIRP spectral densities within the permitted channel frequency boundaries provided by WSDB.
- A time validity of 60 minutes and a location validity of 50 meters.
- A T<sub>Update</sub> of 60 seconds.
- A simultaneous channel operation power restriction value of 0, i.e. no restriction.

# 5.3 Void

# 5.4 Essential test suites

# 5.4.1 Product Information

The following information shall be provided in order to carry out the test suites. This information shall form an integral part of the test report. The application form contained in annex F may be used to provide this information:

a) The unique identifier, device emission class (1, 2, 3, 4 or 5), technology identifier, type (A or B) and category (primary or secondary) of the UUT.

NOTE 1: The provision of the unique identifier is only required in order to enable the appropriate communication between the UUT and the TE.

- b) The operating frequency range(s) of the equipment within the 470 MHz to 694 MHz band.
- c) A declaration as to whether the UUT can support simultaneous transmissions in multiple DTT channels (contiguous and/or non-contiguous).
- d) The nominal channel bandwidth(s) supported ( $n \times 8$  MHz where  $n \ge 1$ ).
- e) The maximum *total* nominal channel bandwidth supported (m  $\times$  8 MHz where m  $\ge$  1).
- f) Groupings of DTT channels.
- NOTE 2: If the specified nominal channel bandwidths are 8 MHz and 16 MHz, and the specified maximum total nominal channel bandwidth is 32 MHz, then the following DTT channel groupings are possible (where "-" separates non-contiguous DTT channels): 1, 1-1, 1-2, 1-1-1, 1-1-1-1, 1-1-2, 2-2.
- g) The maximum RF power spectral density (EIRP) in 100 kHz supported by the UUT.
- h) The maximum RF power (EIRP) supported by the UUT.
- i) The types of modulation and multiple access schemes employed by the UUT.
- j) The modulation and multiple access scheme used by the UUT for each of the RF tests (see clause 5.2.5).
- k) The integral or dedicated antenna design used by the equipment and measures to prevent the user from connecting a different antenna.
- For a TVWSD with dedicated antenna(s), the antenna gain of the antenna assembly, and any beamforming
  gain (beyond the summation of the emissions from each antenna) intended to be used in combination with the
  equipment.
- m) For a Type A TVWSD with external antenna(s), the highest value of antenna gain intended to be used with the equipment.
- n) The different transmit operating modes in which the equipment can operate (see clause 5.2.4).
- o) The manufacturer shall specify whether (in the case of secondary TVWSDs) the equipment has horizontal geolocation capability, and also whether (in the case of primary TVWSDs and secondary TVWSDs) the

equipment includes vertical geo-location.

- p) For a secondary UUT, the manufacturer shall specify if the UUT is capable of requesting specific operational parameters from a primary TVWSD.
- q) For a secondary UUT, the manufacturer shall specify whether the UUT is capable of communicating directly with another secondary TVWSD. If the UUT has such a capability, the manufacturer shall also specify that the UUT will remain under the control of its serving primary TVWSD when operating in this mode.
- r) The normal and the extreme operating conditions (e.g. voltage and temperature) that apply to the equipment.
- s) For each of the tests to be performed, the worst case operational mode (e.g. power settings, modulation, antennas, etc.) with respect to the test being performed.
- t) The manufacturer shall also specify the parameters described above for any test primary TVWSD or test secondary TVWSD which it provides for the purposes of testing the UUT.
- u) The regulatory domains supported by the device.

# 5.4.2 RF output power

# 5.4.2.1 Test conditions

See clause 5.2 for the test conditions. The measurements for RF output power shall be performed at both normal environmental conditions and at the extremes of the operating temperature range.

In the case of equipment intended for use with an integral antenna and where no external (temporary) antenna connectors are provided, a test fixture as described in clause B.3 may be used to perform relative measurements at the extremes of the operating temperature range.

The equipment shall be operated under its worst case configuration (for example modulation, bandwidth, data rate, power) with regards to RF output power. Measurement of multiple data sets may be required.

#### 5.4.2.2 Test method

#### 5.4.2.2.1 Conducted measurements

In case of conducted measurements the transmitter shall be connected to the measuring equipment by a suitable method. The RF power as defined in clause 4.2.4 shall be measured and recorded.

The test procedure shall be as follows:

#### Step 1:

- Use a fast power sensor suitable for a minimum of 1 GHz and suitable for measurements at 10<sup>6</sup> Samples/s or faster.
- Use the following settings:
  - Sample speed 1 MS/s or faster.
  - The samples shall represent the power of the signal.
  - Measurement duration: sufficient to capture a minimum of 10 bursts.

The above sampling speed assumes the minimum transmission time is at least 20  $\mu$ s; otherwise the sampling speed needs to be adjusted accordingly.

#### Step 2:

- For conducted measurements on devices with one transmit chain:
  - Connect the power sensor to the transmit port, sample the transmit signal and store the raw data. Use these stored samples in all following steps.
- For conducted measurements on devices with multiple transmit chains:
  - Connect one power sensor to each transmit port for a synchronous measurement on all transmit ports.
  - Trigger the power sensors so that they start sampling at the same time. Make sure the time difference between the samples of all sensors is less than 500 ns.
  - For each individual sampling point (time domain), sum the coincident power samples of all ports and store them. Use these summed samples in all following steps.

# **Step 3:**

- Find the start and stop times of each burst in the stored measurement samples:
  - The start and stop times are defined as the points where the power is at least 30 dB below the highest value of the stored samples in step 2.

In case of insufficient dynamic range, the value of 30 dB may need to be reduced appropriately.

#### **Step 4:**

• Between the start and stop times of each individual burst calculate the RMS power averaged over the burst using the formula below. Save these P<sub>burst</sub> values, as well as the start and stop times for each burst:

$$P_{burst} = \frac{1}{k} \sum_{n=1}^{k} P_{sample} (n)$$

with "k" being the total number of samples and 'n' the actual sample number.

#### Step 5:

The highest of all P<sub>burst</sub> values (value "A" in dBm) will be used for maximum EIRP calculations.

#### Step 6:

- Add the (stated) antenna assembly gain "G" in dBi of the individual antenna.
- If applicable, add the additional beamforming gain "Y" in dB.
- If more than one antenna assembly is intended for this power setting, the maximum overall antenna gain (G or G + Y) shall be used.
- The RF Output Power (P) shall be calculated using the formula below:

$$P = A + G + Y$$

• This value, which shall comply with the limit given in clause 4.2.4.2, shall be recorded in the test report.

## 5.4.2.2.2 Radiated measurements

This method shall only be used for integral antenna equipment which does not have a temporary antenna connector(s) provided.

When performing radiated measurements, the UUT shall be configured and antenna(s) positioned (including smart antenna systems and systems capable of beamforming) for maximum EIRP towards the measuring antenna.

A test site as described in annex B and applicable measurement procedures as described in annex C shall be used.

Taking into account the calibration factor from the measurement site, the test procedure is further as described under clause 5.4.2.2.1.

# 5.4.3 Power Spectral Density and Transmitter unwanted emissions within the 470 MHz to 694 MHz band

## 5.4.3.1 Test conditions

See clause 5.2 for the test conditions. These measurements shall only be performed at normal test conditions (see clause 5.1.2).

The UUT shall be configured to transmit under normal operating conditions which result in the lowest adjacent frequency leakage ratios inside the 470 MHz to 694 MHz band.

# 5.4.3.2 Test method

## 5.4.3.2.1 Conducted measurement

The transmitter shall be connected to a spectrum analyser and the power spectral density as defined in clause 4.2.4 shall be measured and recorded.

For a UUT that can at most transmit in a single DTT channel, the test TVWSDB shall be configured as follows:

- Set the permitted lower channel edge frequency and upper channel edge frequency so that they coincide with the lowest DTT channel in the operating frequency range specified by the manufacturer.
- Set the maximum permitted in-block RF power spectral density (in 100 kHz) to the maximum in-block RF power spectral density (in 100 kHz) specified by manufacturer.
- Set the maximum permitted in-block RF power (in 8 MHz) to the UUT maximum in-block RF power (in 8 MHz) specified by manufacturer.

When the tests have been performed, they should then be repeated with the equipment set to the middle and highest DTT channels in the operating frequency range specified by the manufacturer.

For a UUT that can also transmit simultaneously in a group of contiguous DTT channels, the test shall be repeated with the test TVWSDB configured as follows:

- Set the permitted lower and upper channel edge frequencies so that they coincide with those of a group of
  contiguous DTT channels that fall at the middle of the operating frequency range specified by the
  manufacturer.
- Set the maximum nominal channel bandwidth in accordance with the highest value specified by the manufacturer.
- Set the maximum permitted in-block RF power spectral density (in 100 kHz) for each DTT channel to the maximum in-block RF power spectral density (in 100 kHz) specified by the manufacturer.
- Set the maximum permitted in-block RF power spectral density (in 8 MHz) for each DTT channel to the UUT maximum in-block RF power spectral density (in 8 MHz) specified by manufacturer.

For a UUT that can also transmit simultaneously in multiple non-contiguous (or a mixture of contiguous and non-contiguous) DTT channels, the test shall be repeated with the test TVWSDB configured as follows:

- Set the permitted lower and upper channel edge frequencies so that they correspond to multiple non-contiguous (or a mixture of contiguous and non-contiguous) DTT channels that fall within the operating frequency range specified by the manufacturer.
- Set the maximum total nominal channel bandwidth in accordance with the maximum total nominal channel bandwidth specified by the manufacturer.
- Set the maximum permitted in-block RF power spectral density (in 100 kHz) for each DTT channel to the maximum in-block RF power spectral density (in 100 kHz) specified by the manufacturer.
- Set the maximum permitted in-block RF power spectral density (in 8 MHz) for each DTT channel to the UUT maximum in-block RF power spectral density (in 8 MHz) specified by manufacturer.

The tests shall be repeated for a selection of the specified grouping of DTT channels.

The test procedure shall be as follows:

#### Step 1:

Connect the UUT to the spectrum analyser and use the following settings:

• Start Frequency: 470 + RBW / 2 MHz

• Stop Frequency: 694 - RBW / 2 MHz

• Resolution BW (RBW): 10 kHz

• Video BW: 30 kHz

• Sweep Points/"Samples": Frequency span / RBW

For spectrum analysers not supporting this number of sweep points, the frequency band shall be segmented. But the Start / Stop Frequency for any segment shall always coincide with a DTT channel edge, taking into account the RBW.

• Detector: RMS

Trace Mode: Max Hold

• Sweep time: 1 ms per sample point

For non-continuous signals, wait for the trace to be stabilized.

Save the data (trace data) set to a file.

## Step 2:

For conducted measurements on smart antenna systems using either operating mode 2 or operating mode 3 (see clause 5.2.4), repeat the measurement for each of the transmit ports. For each sampling point (frequency domain), add up the coincident (power) values for the different transmit chains and use this as the new data set.

#### Step 3:

Add up the values (in the linear domain) for power for all the Sweep Points (P<sub>sample</sub>) in the file using the formula below:

$$P = \sum_{n=1}^{k} P_{sample} (n)$$

with "k" being the total number of samples and 'n' the actual sample number.

#### Step 4:

Normalize the individual values for power so that the sum is equal to the RF Output Power (EIRP) measured in clause 5.4.2.

#### **Step 5:**

Consider the samples in the first DTT channel.

#### Step 6:

Starting from the first sample in the file (lowest frequency), add up the power of the first 10 samples representing a 10 kHz segment and record the results for power and position (i.e. sample number 1 to sample number 10). This is the Power Spectral Density (EIRP) for the first 100 kHz segment within the DTT channel being considered, which shall be recorded.

#### **Step 7:**

Within the current DTT channel, shift the start point of the samples added up in step 6 by one sample and repeat the procedure in step 6 (i.e. sample number 2 to sample number 11).

#### **Step 8:**

Repeat step 7 until the end of the data set for the DTT channel being considered, and record the power spectral density values for each of the 100 kHz segments within this DTT channel.

#### Step 9:

Compare the power spectral density measured for each of the 100 kHz segment with the limit (in-band power spectral density (clause 4.2.4), or unwanted emission (clause 4.2.5.2), as appropriate) that applies for this DTT channel.

If the device is reporting a spectral mask improvement, check that the power spectral density of the segment being considered is below  $P_{OOB}$  -  $\Delta ACLR(n_{IB}, n_{OOB})$ .  $P_{OOB}$  is the out of block emission for the device emission class being specified, and  $\Delta ACLR(n_{IB}, n_{OOB})$  is the value obtained by the test database for the corresponding in block channel  $(n_{IB})$  and the out of block section being considered.

#### **Step 10:**

Repeat step 6 to step 9 for the samples in each subsequent DTT channel.

#### **Step 11:**

For DTT channels in which the UUT has wanted emissions, add up the power for the corresponding 800 samples (10 kHz segments) that fall within this DTT channel. This is the total power within this 8 MHz channel. This value shall be compared to the limit that applies for this DTT channel.

#### 5.4.3.2.2 Radiated measurement

This method shall only be used for integral antenna equipment which does not have a temporary antenna connector(s) provided.

When performing radiated measurements, the UUT shall be configured and antenna(s) positioned (including smart antenna systems and systems capable of beamforming) for maximum EIRP towards the measuring antenna.

A test site as described in annex B and applicable measurement procedures as described in annex C shall be used.

Taking into account the calibration factor from the measurement site, the test procedure is further as described under clause 5.4.3.2.1.

## 5.4.4 Transmitter unwanted emissions outside the 470 MHz to 694 MHz band

#### 5.4.4.1 Purpose

The objective of these tests is to ensure that the UUT unwanted emissions outside the 470 MHz to 694 MHz band comply with the requirements set out in clause 4.2.5.1.

#### 5.4.4.2 Test conditions

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

The level of spurious emissions shall be measured as, either:

- a) their power in a specified load (conducted spurious emissions) and their effective radiated power when radiated by the cabinet or structure of the equipment (cabinet radiation); or
- b) their effective radiated power when radiated by cabinet and antenna in case of integral antenna equipment with no temporary antenna connectors.

The UUT shall be configured to the worst case operational mode for this requirement.

For a UUT which is capable of transmitting simultaneously in multiple DTT channels, the UUT shall be configured to transmit in one group of contiguous DTT channels, with equal power in each DTT channel, and at the maximum total nominal channel bandwidth specified by the manufacturer.

The UUT shall be configured such that the occupied nominal channels are tested at the upper and lower ends of the operating frequency range specified by the manufacturer.

#### 5.4.4.3 Test method

#### 5.4.4.3.1 Conducted measurements

The UUT shall be connected to a spectrum analyser.

#### a) Frequency scan

The frequency scan test procedure shall be used to identify potential transmitter unwanted emissions of the UUT.

#### Step 1:

The sensitivity of the measurement set-up shall be such that the noise floor is at least 12 dB below the limits given in table 1.

#### Step 2:

The emissions shall be measured over the range 30 MHz to 1 000 MHz (but excluding the 470 MHz to 694 MHz band) with the spectrum analyser settings in table 9.

Table 9: Spectrum analyser settings

Sweep time	For non-continuous transmissions (duty cycle less than 100 %), the sweep time shall be sufficiently long, such that for each 100 kHz frequency step, the measurement time is greater than two transmissions of the UUT.

Any emissions identified during the above sweeps which fall above the applicable limit, or within the 6 dB range below the applicable limit given in table 1 shall be individually measured using the *measurement of identified emissions* procedure below.

#### **Step 3:**

The emissions shall now be measured over the range 1 GHz to 4 GHz with the spectrum analyser settings in table 10.

Sweep Time:	For non-continuous transmissions (duty cycle less than 100 %), the sweep time shall be sufficiently long, such that for each 1 MHz frequency step, the measurement time is greater than two transmissions of the UUT.

Any emissions identified during the above sweeps which fall above the applicable limit, or within the 6 dB range below the applicable limit given in table 1 shall be individually measured using the *measurement of identified emissions* procedure below.

#### Step 4:

In case of conducted measurements on smart antenna systems (equipment with multiple transmit chains), the step 2 and step 3 need to be repeated for each of the active transmit chains  $(A_{ch})$ .

The limits used to identify emissions during this frequency scan need to be reduced by  $10 \times \log_{10} (A_{ch})$ ; where  $A_{ch}$  is the number of active transmit chains.

#### b) Measurement of the emissions identified during the frequency scan

The steps below shall be used to accurately measure the individual unwanted emissions identified during the frequency scan measurements above.

#### Step 1:

The level of the emissions shall be measured using the spectrum analyser settings in table 11.

#### Step 2:

In case of conducted measurements on smart antenna systems (equipment with multiple transmit chains), the step 1 needs to be repeated for each of the active transmit chains  $(A_{ch})$ .

The trace data for each transmit chain has to be recorded.

Sum the power in each of the traces for each individual frequency bin.

#### Step 3:

Use the marker function to find the highest peak within the measurement trace and record its value and its frequency.

#### Step 4:

The measured values shall be compared to the limits defined in table 1.

Repeat the above procedures for every emission identified during the frequency scan.

#### 5.4.4.3.2 Radiated measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

#### 5.4.5 Transmitter Intermodulation

#### 5.4.5.1 Objective and Measurement Arrangement

The objective of this test is to verify whether the UUT complies with the requirements and limits in clause 4.2.6.2.




Figure 3: Transmitter Intermodulation Test Set-Up

The test set-up is shown in figure 3.

#### 5.4.5.2 Test Conditions

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

#### 5.4.5.3 Test Method

#### 5.4.5.3.1 Conducted Measurements

- Step 1: Configure the UUT to operate on the centre channel of the range specified by the manufacturer, and to operate at the maximum RF output power level  $(P_{IBMax})$ .
- **Step 2:** Connect the power meter to the port C1 of the directional coupler. Measure the output power of the UUT taking account of the coupling loss of the coupler.
- **Step 3:** Connect the power meter to port C2 of the directional coupler. Switch on and configure the signal generator to produce the unwanted test signal as defined in clause 4.2.6.2.

Step 4: Connect the spectrum analyser to port C1 of the directional coupler and measure the level of the third-order product which is at the frequency  $2 \times f_w$  -  $f_{un}$ . This should be measured in a 100 kHz bandwidth. Confirm that the UUT complies with the requirements contained in clause 4.2.6.2.

If the device supports the reporting of the intermodulation improvement ( $\Delta RIM3(P_{IBk})$ ) the following additional steps need to be performed.

- Step 5: Decrease the power  $P_{IBk-1}$  to next power down  $(P_{IBk-1} < P_{IBk})$  and measure the third intermodulation product as described in step 4. Calculate  $\Delta RIM3(P_{IBk})$  and check that is it higher or equal to the value reported to the test database.
- **Step 6:** Repeat step 5 for decreasing values of k until the last supported power is used (P<sub>IB1</sub>).

#### 5.4.5.3.2 Radiated measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

### 5.4.6 Primary TVWSD update

#### 5.4.6.1 Introduction and Test conditions

This test verifies that a primary TVWSD complies with the requirements in clause 4.2.7.3.

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions. For the purposes of carrying out this test, the primary device shall be set to a test mode that bypasses the authentication of the weblisting server and of the controlling TVWSDB.

The UUT shall be configured to:

- identify the test TVWSDB in the TE, obtain operational parameters from the TVWSDB for itself and operate according to those parameters;
- 2) if the UUT supports broadcasting generic operational parameters, consult the test TVWSDB to obtain generic operational parameters;
- 3) if the UUT supports provision of specific operational parameters to secondary TVWSDs, process the request for specific operational parameters from the test secondary.

If the UUT does not support sleep mode, the test TVWSDB shall be configured to (CONFIGURATION1):

- 1) allow the UUT to identify the test TVWSDB in the TE;
- 2) emulate the normal operations of a TVWSDB in terms of its data exchange with a primary device;
- 3) provide the operational parameters described in the operational parameter set (see clause 5.2.7) when:
  - a) the UUT requests operational parameters for itself;
  - b) the UUT requests generic operational parameters; and
  - c) the UUT requests specific operational parameters for the test secondary;
- 4) 60 seconds after of providing operational parameters to the primary TVWSD, update the primary TVWSD that the operational parameters are still valid;
- 5) 120 seconds after providing operational parameters to the primary TVWSD, update the primary TVWSD that its operational parameters and those of secondary TVWSDs attached to it are no longer valid.

If the UUT supports sleep mode, the test TVWSDB shall be configured to (CONFIGURATION2):

- 1) Items 1) to 3) in CONFIGURATION1 above.
- 2) Update the UUT every 60 seconds to confirm that the operational parameters are still valid.

The test secondary TVWSD shall be configured to use generic operational parameters-if the UUT supports this functionality-and to request generic and specific operational parameters-if the UUT supports this functionality.

#### 5.4.6.2 Test method

#### 5.4.6.2.1 Conducted Measurements

The following test method applies to all primary TVWSDs. The test TVWSDB shall be configured in accordance with CONFIGURATION1:

- a) Switch off the UUT. Switch off the test secondary TVWSD. Connect the UUT to the TE. Connect the test secondary TVWSD to the UUT. Connect the UUT to a spectrum analyser.
- b) Switch on the UUT. Switch on the test secondary TVWSD. Confirm that the UUT consults the TE and identifies the TVWSDB.
- c) Confirm that the UUT identifies the test TVWSDB, obtains operational parameters for itself and transmits in accordance with the operational parameters via the spectrum analyser.
- d) Confirm that the test secondary TVWSD obtains generic operational parameters and specific operational parameters if the UUT supports the functionalities to provide these.
- e) Confirm that, 60 seconds after the operational parameters for the UUT where provided, the UUT either requests an update from the test TVWSDB (pull mode) or acknowledges reception of an update from the test TVWSDB (push mode).
- f) Confirm via the spectrum analyser that the UUT is still transmitting according to the operational parameters provided by the test TVWSDB.
- g) Confirm that, 120 seconds after the operational parameters for the UUT were provided, the UUT either requests an update from the test TVWSDB (pull mode) or acknowledges reception of an update from the test TVWSDB (push mode).
- h) Confirm via the spectrum analyser that the UUT has stopped transmitting in the 470 MHz to 694 MHz band.
- i) Confirm that the UUT has communicated the test secondary TVWSD to stop transmitting.

In addition, if the UUT supports sleep mode, the following test should be carried out. The test TVWSDB shall be configured in accordance with CONFIGURATION2:

- a) Repeat step a) to step f) above.
- b) Wait 3 minutes. Instruct the UUT to go into sleep mode for 150 seconds. Confirm, via the spectrum analyser, that the UUT stops transmissions.
- c) Confirm, via the spectrum analyser, that the UUT does not transmit in the 470 MHz to 694 MHz band for at least 150 seconds.
- d) Confirm that the UUT either requests an update from the test TVWSDB (pull mode) or acknowledges an update from the test TVWSDB (push mode) before starting transmissions.
- e) Confirm, via the spectrum analyser, that the UUT transmits in accordance with the operational parameters provided by the test TVWSDB.

#### 5.4.6.2.2 Radiated Measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

#### 5.4.7 Lost connection between the primary TVWSD and the TVWSDB

#### 5.4.7.1 Test conditions

For the purposes of carrying out this test, the UUT shall be set to a test mode that bypasses the authentication of the weblisting server and of the controlling TVWSDB.

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

The UUT shall be configured to:

- 1) identify the test TVWSDB in the TE, obtain operational parameters from the TVWSDB for itself and operate according to those parameters;
- 2) if the UUT supports generic operational parameters, consult the test TVWSDB to obtain generic operational parameters;
- 3) if the UUT supports provision of specific operational parameters to secondary TVWSDs, process the request for specific operational parameters from the test secondary.

The test TVWSDB shall be configured to:

- 1) allow the UUT to identify the test TVWSDB in the TE;
- 2) emulate the normal operations of a controlling TVWSDB in terms of its data exchange with a primary device;
- 3) provide the operational parameters described in the operational parameter set (clause 5.2.7) when:
  - a) the UUT requests operational parameters for itself;
  - b) the UUT requests generic operational parameters; and
  - c) the UUT requests specific operational parameters for the test secondary.

The test secondary TVWSD shall be configured to use generic operational parameters - if the UUT supports this functionality - and to request generic and specific operational parameters-if the UUT supports this functionality.

#### 5.4.7.2 Test method

#### 5.4.7.2.1 Conducted Measurements

- a) Switch off the UUT. Switch off the test secondary TVWSD. Connect the UUT to the TE. Connect the test secondary TVWSD to the UUT. Connect the UUT to a spectrum analyser.
- b) Switch on the UUT. Switch on the test secondary TVWSD. Confirm that the UUT consults the TE and identifies the test TVWSDB.
- c) Confirm that the UUT identifies the test TVWSDB, obtains operational parameters for itself and transmits in accordance with the operational parameters via the spectrum analyser.
- d) Confirm that the test secondary TVWSD obtains generic operational parameters and specific operational parameters if the UUT supports the functionalities to provide these.
- e) Confirm that, 60 seconds after the operational parameters for the UUT where provided, the UUT either requests an update from the test TVWSDB (pull mode) or acknowledges reception of an update from the test TVWSDB (push mode).
- f) Confirm via the spectrum analyser that the UUT is still transmitting in accordance with the operational parameters provided by the test TVWSDB.
- g) Disconnect the UUT from the test TVWSDB.
- h) Confirm that, no later than 60 seconds after g), the UUT stops transmissions and commands the test secondary to stop transmissions.

#### 5.4.7.2.2 Radiated Measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

### 5.4.8 Secondary TVWSD update - specific parameters invalidated

#### 5.4.8.1 Test conditions

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

For the purposes of carrying out this test, the primary device shall be set to a test mode that bypasses the authentication of the weblisting server and of the controlling TVWSDB.

The UUT shall be configured to:

- 1) identify the test TVWSDB in the TE, obtain operational parameters from the TVWSDB for itself and operate according to those parameters;
- 2) if the UUT supports broadcasting generic operational parameters, consult the test TVWSDB to obtain generic operational parameters;
- 3) provision of specific operational parameters to secondary TVWSDs, process the request for specific operational parameters from the test secondary.

#### 5.4.8.2 Test method

#### 5.4.8.2.1 Conducted Measurements

The test method below applies to the case where specific operational parameters for a secondary UUT are invalidated. The test method applies to conducted measurements and the measurement procedure shall be as follows:

- a) Switch off the UUT. Connect the UUT to a test primary TVWSD (which is itself connected to the test TVWSDB) and a spectrum analyser.
- b) Switch on the UUT. Confirm, via the spectrum analyser, that the UUT transmits according to either generic operational parameters or the specific operational parameters provided by the test TVWSDB.
- c) Command the test primary TVWSD to update the UUT that its specific operational parameters are no longer valid.
- d) Confirm, via the spectrum analyser, that the UUT stops transmitting in accordance with the specific operational parameters provided.

The UUT may continue transmitting according to the generic operational parameters.

If the UUT supports sleep mode, the following additional steps shall be carried out:

- e) Repeat step a) and step b).
- f) Wait three minutes. Instruct the UUT to go into sleep mode for 150 seconds. Confirm, via the spectrum analyser, that the UUT stops transmissions.
- g) Set the primary TVWSD to indicate to the UUT that the specific operational parameters are not valid.
- h) Confirm, via the spectrum analyser, that the UUT does not transmit for at least 150 seconds.
- i) Once the 150 seconds have elapsed, confirm, via the spectrum analyser, that the UUT does not resume transmission according to the specific operational parameters it had previously obtained.

## 5.4.9 Secondary TVWSD update - loss of communication with primary TVWSD

#### 5.4.9.1 Test conditions

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

For the purposes of carrying out this test, the primary device shall be set to a test mode that bypasses the authentication of the weblisting server and of the controlling TVWSDB.

The UUT shall be configured to:

- 1) identify the test TVWSDB in the TE, obtain operational parameters from the TVWSDB for itself and operate according to those parameters;
- 2) if the UUT supports broadcasting generic operational parameters, consult the test TVWSDB to obtain generic operational parameters;
- 3) if the UUT supports provision of specific operational parameters to secondary TVWSDs, process the request for specific operational parameters from the test secondary.

#### 5.4.9.2 Test method

#### 5.4.9.2.1 Conducted Measurements

The test method below applies to the case where a secondary UUT loses communications with the primary test TVWSD. The test method applies to conducted measurements and the measurement procedure shall be as follows:

- a) Switch off the UUT. Connect the UUT to a test primary TVWSD (which is itself connected to the test TVWSDB) and a spectrum analyser.
- b) Switch on the UUT. Confirm, via the spectrum analyser, that the UUT transmits according to either generic operational parameters or the specific operational parameters provided by the test TVWSDB.
- c) Disconnect the primary TVWSD from the UUT.
- d) Confirm, via the spectrum analyser, that the UUT stops transmitting within five seconds.

#### 5.4.9.2.2 Radiated Measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

### 5.4.10 Receiver Sensitivity level

#### 5.4.10.1 Test conditions

See clause 5.2 for the test conditions. These measurements shall only be performed at normal test conditions.

The equipment shall be tested operating at both the lowest and highest operating channels.

If the equipment can operate with different Nominal Channel Bandwidths, then the smallest channel bandwidth shall be used. The equipment shall be configured in a mode that results in the lowest data rate for this channel bandwidth.

#### 5.4.10.2 Test method

#### 5.4.10.2.1 Conducted Measurements




Figure 4: Test Set-up for receiver Sensitivity

Figure 4 of clause 5.4.10.2.2 shows the test set-up.

Step 1 and step 2 below define the procedure to verify the Receiver Sensitivy requirement as described in clause 4.2.8.

#### Step 1:

- A communication link is established between the UUT and the associated companion device using the test setup shown in figure 4. The attenuation of the variable attenuator shall be increased in 1 dB steps to a value at which the minimum performance criteria as specified in clause 4.2.8.3 is still met.
- The level of the wanted signal measured at the UUT input is the Receiver Sensitivity (P<sub>min</sub>) for the UUT.

#### Step 2:

• Repeat step 1 for the highest channel used by the equipment.

#### 5.4.10.2.2 Radiated measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

## 5.4.11 Adjacent Channel Selectivity

#### 5.4.11.1 Test conditions

These measurements shall only be performed at normal test conditions (see clause 5.1.2).

The UUT shall operate in its normal operational mode.

If the equipment can be configured to operate with different Nominal Channel Bandwidths and different data rates, then the combination of the smallest channel bandwidth and the lowest data rate for this channel bandwidth which still allows the equipment to operate as intended shall be used. This mode of operation shall be aligned with the performance criteria defined in clause 4.2.9.3 and shall be described in the test report.

It shall be verified that this performance criteria as defined by the manufacturer is achieved during the blocking test.

#### 5.4.11.2 Test Method

#### 5.4.11.2.1 Conducted measurements




Figure 5: Test Set-up for receiver adjacent channel selectivity

Figure 5 shows the test set-up which can be used for performing the receiver adjacent channel selectivity test. The companion device may require appropriate shielding or may need to be put in a shielded room to prevent it may have a negative impact on the measurement.

The steps below define the procedure to verify the receiver blocking requirement as described in clause 4.2.9.

#### Step 1:

• The interference source is set to operate in the upper adjacent channel using the frequency offset as defined in table 6.

#### Step 2:

- With the interference source switched off a communication link is set up between the UUT and the associated companion device using the test setup shown in figure 5. The attenuation of the variable attenuator shall be increased in 1 dB steps to a value at which the minimum performance criteria as specified in clause 4.2.9.3 is still met. The resulting level for the wanted signal at the input of the UUT is P<sub>min</sub>.
- This signal level  $(P_{min})$  is increased by 10 dB resulting in a new level  $(P_{min} + 10 \text{ dB})$  of the wanted signal at the UUT receiver input.

#### Step 3:

- The level of the interference source at the UUT input is set to the level provided in table 6. It shall be verified and recorded in the test report that the performance criteria as specified in clause 4.2.9.3 are met.
- If the performance criteria as specified in clause 4.2.9.3 are met, the level of the interference source at the UUT may be further increased (e.g. in steps of 1 dB) until the level whereby the performance criteria as specified in clause 4.2.9.3 are no longer met. The highest level at which the performance criteria are met is recorded in the test report.

#### Step 4:

• Repeat step 2 to step 5 with the UUT operating at the highest operating channel.

#### 5.4.11.2.2 Radiated measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

## 5.4.12 Receiver Blocking

#### 5.4.12.1 Test conditions

See clause 5.2 for the environmental test conditions. These measurements shall only be performed at normal test conditions.

The equipment shall be tested operating at both the lowest and highest operating channels.

If the equipment can be configured to operate with different Nominal Channel Bandwidths (e.g. 6 MHz and 8 MHz) and different data rates, then the combination of the smallest channel bandwidth and the lowest data rate for this channel bandwidth which still allows the equipment to operate as intended shall be used. This mode of operation shall be aligned with the performance criteria defined in clause 4.2.9.3.

#### 5.4.12.2 Test Method

#### 5.4.12.2.1 Conducted measurements

For systems using multiple receive chains only one chain (antenna port) shall be tested. All other receiver inputs shall be terminated.




Figure 6: Test Set-up for receiver blocking

Figure 6 shows the test set-up which can be used for performing the receiver blocking test.

The procedure in step 1 to step 6 below shall be used to verify the receiver blocking requirement as described in clause 4.2.10.

Table 7 in clause 4.2.10.4 contains the applicable blocking frequencies and blocking levels.

#### Step 1:

• The blocking signal generator is set to the first frequency from table 7.

#### Step 2:

- With the blocking signal generator switched off, a communication link is established between the UUT and the associated companion device using the test setup shown in figure 6. The attenuation of the variable attenuator shall be increased in 1 dB steps to a value at which the minimum performance criteria as specified in clause 4.2.8.3 is still met. The resulting level for the wanted signal at the input of the UUT is P<sub>min</sub>.
- This signal level (P<sub>min</sub>) is increased by the value provided in the table corresponding to the receiver category and type of equipment.

#### Step 3:

• The blocking signal at the UUT is set to the level provided in table 6. It shall be verified and recorded in the test report that the performance criteria as specified in clause 4.2.8.3 is met.

#### Step4:

• Repeat step 4 for each remaining combination of frequency and level for the blocking signal as provided in table 7.

#### Step5:

• Repeat step 2 to step 5 with the UUT operating at the highest operating channel.

#### 5.4.12.2.2 Radiated measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

## 5.4.13 Receiver spurious emission

#### 5.4.13.1 Purpose

The objective of these tests is to ensure that the UUT receiver spurious emissions comply with the specifications set out in clause 4.2.11.

#### 5.4.13.2 Test conditions

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

For the duration of the test, the UUT shall be configured to operate in a continuous receive mode, or is operated in a mode where no transmissions occur.

The level of spurious emissions shall be measured as, either:

- their power in a specified load (conducted spurious emissions) and their effective radiated power when radiated by the cabinet or structure of the equipment (cabinet radiation); or
- their effective radiated power when radiated by cabinet and antenna in case of integral antenna equipment with no temporary antenna connectors.

#### 5.4.13.3 Test method

#### 5.4.13.3.1 Conducted measurements

The UUT shall be connected to a spectrum analyser.

The frequency scan test procedure below shall be used to identify potential receiver spurious emissions of the UUT.

#### a) Frequency scan

#### Step 1:

The sensitivity of the measurement set-up shall be such that the noise floor is at least 12 dB below the limits given in table 8.

#### Step 2:

The emissions shall be measured over the range 30 MHz to 1 000 MHz, with the spectrum analyser settings in table 12.

**Table 12: Spectrum analyser settings** 

Parameter	Value
Resolution Bandwidth:	100 kHz
Video Bandwidth:	300 kHz
Detector mode:	Peak
Trace mode:	Max Hold

Any emissions identified during the above sweeps which fall above the applicable limit, or within the 6 dB range below the applicable limit given in table 6 shall be individually measured using the *measurement of identified emissions* procedure below.

#### **Step 3:**

The emissions shall now be measured over the range 1 GHz to 4 GHz with the spectrum analyser settings in table 13.

Table 13: Spectrum analyser settings

Any emissions identified during the above sweeps which fall above the applicable limit, or within the 6 dB range below the applicable limit in table 6, shall be individually measured using the measurement of emissions identified during frequency scan procedure below.

#### b) Measurement of the emissions identified during the frequency scan

Step 1 to step 4 below shall be used to accurately measure the individual unwanted emissions identified during the frequency scan measurements above.

#### Step 1:

The level of the emissions shall be measured using the spectrum analyser settings in table 14.

#### Step 2:

In case of conducted measurements on smart antenna systems (equipment with multiple receive chains), step 1 needs to be repeated for each of the active receive chains  $(A_{ch})$ .

The trace data for each receive chain has to be recorded.

Sum the power in each of the traces for each individual frequency bin.

#### Step 3:

Use the marker function to find the highest peak within the measurement trace and record its value and its frequency.

#### Step 4:

The measured values shall be compared to the limits defined in table 8.

Repeat the above procedures for every emission identified during the frequency scan.

#### 5.3.13.3.2 Radiated measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

#### 5.4.14 Control and monitoring functions

#### 5.4.14.1 TVWSDB identification

#### 5.4.14.1.1 Test condition

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

In this test, the UUT is configured to operate normally. The data port of the UUT (i.e. the port that it uses to connect to the Internet) shall be connected to the test port of the Test Equipment (TE). For the purposes of this test, the TE shall provide the following IP related functions:

- Logging of all the IP traffic to and from the UUT.
- Providing Internet connection to the UUT.
- Blocking the IP traffic between the UUT and certain Internet servers.

The TE may also act as an IP DNS server and DHCP server for the UUT.

If the UUT supports GNSS location, then a GNSS signal generator shall be connected to the UUT. The GNSS generator shall be capable of producing signals corresponding to positions located in all the geographical areas covered by the regulatory domains supported by the UUT.

If the UUT does not support GNSS location, then the UUT manufacturer shall provide the means to simulate locations in all the geographical areas covered by the regulatory domains supported by the UUT.

The UE antenna connector shall be connected to a power measuring equipment with an RF bandwidth that exceeds the total operating transmit frequency range of the UUT.

The primary TVWSD may need, prior to consulting the weblisting, to contact an Internet location server to obtain the address of the weblisting that corresponds to its geographical location.




Figure 7: Test arrangement for test database identification and access

The test arrangement is illustrated in figure 7.

#### 5.4.14.1.2 Test Method

#### 5.4.14.1.2.1 Conducted Measurements

#### 5.4.14.1.2.1.0 General

For conducted measurements, the following test procedure shall be used.

#### 5.4.14.1.2.1.1 Test method 1

This test verifies the behaviour of the UUT when the Internet connection is not accessible at start up:

- a) The UUT shall be switched off at the start of the test. The UUT data port shall be disconnected from the TE and from any means to connect to the Internet. The power meter shall be connected to the UHF antenna port of the UUT.
- b) If the UUT is capable of geolocation, the GNSS generator shall be configured to produce the signals corresponding to a position located in a geographical area covered by any of the regulatory domains supported by the UUT.
- c) The UUT shall be switched on for a period of at least fifteen minutes.
- d) The test is passed if the reading of the power meter shows no transmissions from the UUT.

#### 5.4.14.1.2.1.2 Test method 2

This test verifies that a primary TVWSD obtains the weblisting relevant to its geographical location, and contacts one of the approved TVWSDB in the list.

The following test procedure shall be repeated for each of the regulatory domains supported by the UUT:

- a) The UUT shall be switched off at the start of the test. The UUT data port shall be connected to the data port of the TE. The power meter shall be connected to the UHF antenna port of the UUT. The TE shall be configured to log all the IP traffic from and to the UUT.
- b) If the UUT is capable of geolocation, the GNSS generator shall be configured to produce the signals corresponding to a position located in the geographical area covered by the regulatory domain being tested. If the UUT does not support geolocation, the UUT shall be configured to be located in a position within the geographical area covered by the regulatory domain being tested.
- c) The UUT shall be switched on.
- d) Once that the power meter shows that the UUT is transmitting, the UUT can be switched off. Alternatively, if fifteen minutes have elapsed and the UUT has not started transmissions then the UUT can be switched off.
- e) The test if passed if the IP traffic log captured by the TE shows that:
  - 1) The UUT has contacted and downloaded the weblisting relevant to its regulatory domain.
  - 2) The UUT has contacted one of the TVWSDB in the weblisting.

#### 5.4.14.1.2.1.3 Test method 3

This test verifies that a primary TVWSD does not request operational parameters from a TVWSDB that is not on the weblisting:

- a) The UUT shall be switched off at the start of the test. The UUT data port shall be connected to the data port of the TE. The power meter shall be connected to the UHF antenna port of the UUT.
- b) If the UUT is capable of geolocation, the GNSS generator shall be configured to produce the signals corresponding to a position located in the geographical area covered by one of the regulatory domains supported by the UUT. If the UUT does not support geolocation, the UUT shall be configured to be located in a position within the geographical area covered by one of the regulatory domains supported by the UUT.

- c) The TE shall be configured to log all the IP traffic from and to the UUT and to block any traffic between the UUT and the TVWSDBs listed in the relevant weblisting.
- d) The UUT shall be switched on for at least fifteen minutes.
- e) The test is passed if the reading of the power meter shows no transmissions from the UUT and the IP traffic log captured by the TE shows that:
  - 1) The UUT has contacted and downloaded the weblisting relevant to its regulatory domain.
  - 2) The UUT has not contacted a TVWSDB that is not in the weblisting.

#### 5.4.14.1.2.1.4 Test method 4

This test verifies that the primary TVWSD reconsults the weblisting no later than the value of N specified in the weblisting:

- a) The UUT shall be switched off at the start of the test. The UUT data port shall be connected to the data port of the TE. The power meter shall be connected to the UHF antenna port of the UUT. The TE shall be configured to log all the IP traffic from and to the UUT.
- b) If the UUT is capable of geolocation, the GNSS generator shall be configured to produce the signals corresponding to a position located in the geographical area covered by one of the regulatory domains supported by the UUT. If the UUT does not support geolocation, the UUT shall be configured to be located in a position within the geographical area covered by one of the regulatory domains supported by the UUT.
- c) The UUT shall be switched on.
- d) The TE logs shall be checked to confirm that:
  - 1) The UUT has contacted and downloaded the weblisting relevant to the regulatory domain.
  - 2) The UUT has contacted one of the TVWSDB in the weblisting.
- e) The TE shall keep logging the IP traffic until after N.
- f) The TE logs shall be checked to confirm that The UUT has re-contacted and downloaded the weblisting again.

#### 5.4.14.1.2.1.5 Test method 5

This test verifies the behaviour of the primary TVWSD when the weblisting is not available for re-consultation:

- a) The UUT shall be switched off at the start of the test. The UUT data port shall be connected to the data port of the TE. The power meter shall be connected to the UHF antenna port of the UUT. The TE shall be configured to log all the IP traffic from and to the UUT.
- b) If the UUT is capable of geolocation, the GNSS generator shall be configured to produce the signals corresponding to a position located in the geographical area covered by one of the regulatory domains supported by the UUT. If the UUT does not support geolocation, the UUT shall be configured to be located in a position within the geographical area covered by one of the regulatory domains supported by the UUT.
- c) The UUT shall be switched on.
- d) The TE logs shall be checked to confirm that:
  - 1) The UUT has contacted and downloaded the weblisting relevant to the regulatory domain.
  - 2) The UUT has contacted one of the TVWSDB in the weblisting.
- e) The TE shall be configured to block any further traffic between the UUT and the weblisting server.
- f) The TE shall keep logging the IP traffic until after N + 2 hours.
- g) The TE logs shall be checked to confirm that:
  - 1) The UUT has tried to contact the weblisting server a first time before N expired.

2) The UUT has tried to contact the weblisting server a second time no sooner than one hour but no later than two hours after the first try.

#### 5.4.14.1.2.2 Radiated Measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

5.4.14.2 Transmission in compliance with parameters, provision of device parameters, provision of channel usage parameters and primary TVWSD functionality in support of secondary TVWSDs

#### 5.4.14.2.1 Test condition

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.

If the UUT is a primary TVWSD, the device shall be configured such that it first identifies and consults the test TVWSDB in the TE, and then operates normally in terms of its data exchange with a TVWSDB as emulated by the TE. In order to do this, the primary TVWSD shall be configured to communicate with un-authenticated weblisting server and an un-authenticated TVWSDB.

If the UUT is a secondary TVWSD, the device shall be configured such that it operates normally in terms of its data exchange with the test primary TVWSD.

The test setup in figure 4 applies for this test. RF measurements should be conducted with a spectrum analyser.

The Test Equipment (TE) for this test shall:

- Log all the communications to and from the primary TVWSD under test, or the test primary TVWSD (when the UUT is a secondary TVWSD).
- Let the primary TVWSD communicate with servers on the Internet.
- Act as a web server that replicates the website hosting the weblisting relevant to the geographical domain where the test takes place. Configure the weblisting to contain only its own test TVWSDB server.
- Redirect the request from the primary TVWSD for the weblist to its own webserver, instead of the legitimate server from the regulatory domain the where the test takes place.
- Act as a test TVWSDB server and communicate through a protocol that is supported by the primary TVWSD
  under test.
- Emulate the normal operations of a TVWSDB in terms of its data exchange with a primary device.
- The test TVWSDB in the TE shall be configured to respond to requests from the primary TVWSD under test, or from the test primary TVWSD (when the UUT is a secondary TVWSD), as follows:
  - 1) TE CONFIGURATION1:
    - not respond to the UUT requests for operational parameters.
  - 2) TE CONFIGURATION2:
    - provide operational parameters as described in the operational parameter set (see clause 5.2.7).
  - 3) TE CONFIGURATION3:
    - provide operational parameters for the primary TVWSD under test as described in the operational parameter set;
    - provide broadcast generic operational parameters for secondary TVWSDs served by the primary TVWSD under test as described in the operational parameter set;
    - provide specific operational parameters for secondary TVWSDs served by the primary TVWSD under test as described in the operational parameter set.

Where the UUT is a secondary TVWSD, the permitted channel edge frequencies and the maximum permitted EIRP spectral densities shall be set differently for generic operational parameters and specific operational parameters.

#### 5.4.14.2.2 Test Method

#### 5.4.14.2.2.1 Conducted Measurements

#### 5.4.14.2.2.1.0 General

For conducted measurements, the following test procedure shall be used.

#### 5.4.14.2.2.1.1 Test method 1

This test verifies that a primary TVWSD does not transmit in the absence of communications with a weblisting server and a TVWSDB. This test verifies that a secondary TVWSD does not transmit in the absence of a signal from a primary TVWSD

The following test method shall be applied to any TVWSD. A test secondary TVWSD, a test primary TVWSD and a TE are not needed for this test method:

- a) Switch off the UUT. Disconnect the UUT data port (if it has one). Connect the UUT to a spectrum analyser.
- b) Switch on the UUT.
- c) Confirm via the spectrum analyser that the UUT does not transmit.
- d) Wait 10 minutes to conclude the test.

#### 5.4.14.2.2.1.2 Test method 2

This test verifies that a primary TVWSD only transmits in accordance with operational parameters that it has received from a TVWSDB, that it reports its device parameters accurately and that it reports its channel usage parameters accurately.

The test method shall be applied in the case where the UUT is a primary TVWSD. A test secondary is not needed for this test method:

- a) Set the TE to CONFIGURATION1.
- b) Switch off the UUT. Connect the UUT to the TE. Connect the UUT to a spectrum analyser.
- c) Switch on the UUT. Confirm that the UUT consults the TE and identifies the TVWSDB.
- d) Confirm, via the spectrum analyser, that the UUT does not transmit in the UHF TV band.
- e) Set the TE to CONFIGURATION2 and repeat step b) and step c).
- f) Confirm that the UUT communicates its device parameters to the TE, and that the parameters are accurate as described in clause 4.2.7.3.2.
- g) The TE then shall respond with operational parameters described in CONFIGURATION2.
- h) Confirm, via the spectrum analyser, that the UUT transmits in accordance with the operational parameters.
- i) If the UUT total EIRP is higher than the value specified in clause 4.2.7.3.2, confirm that the UUT has communicated channel usage parameters to the TE and that the actual transmissions are in accordance with those parameters.
- j) Wait until the validity of the operational parameters expires and confirm that the UUT stops transmitting according to the operating parameters.

#### 5.4.14.2.2.1.3 Test method 5

This test verifies the functionality of a secondary TVWSD.

The test method shall be applied in the case where the UUT is a secondary TVWSD that supports generic operational parameters:

- a) Set the TE to CONFIGURATION3.
- b) Switch off the test primary TVWSD. Switch off the UUT. Connect the test primary TVWSD to the TE. Connect the UUT to the test primary TVWSD. The test primary TVWSD shall be configured such that it operates normally in terms of its data exchange with a TVWSDB as emulated by the TE. Connect the UUT to a spectrum analyser.
- c) Switch on the UUT.
- d) Confirm via the test primary TVWSD that the UUT communicates its unique device identifier to the test primary TVWSD. The UUT may also provide the rest of device parameters.
- e) Confirm, via the spectrum analyser, that the UUT transmits in accordance with the generic operational parameters broadcasted by the test primary TVWSD.
- f) If the UUT total EIRP is greater than the value specified in clause 4.2.7.3.2, confirm that the UUT communicates channel usage parameters to the test primary TVWSD and that the actual transmissions are in accordance with those parameters.
- g) Wait until the time validity of the operational parameters expires and confirm that the UUT stops transmitting according to the operating parameters.

#### 5.4.14.2.2.1.4 Test method 6

This test method verifies the functionality of a secondary TVWSD.

The test method shall be applied in the case where the UUT is a secondary TVWSD that supports specific operational parameters. The UUT shall be configured to request specific operational parameters after it has received generic operational parameters:

- a) Set the TE to CONFIGURATION3.
- b) Switch off the test primary TVWSD. Switch off the UUT. Connect the test primary TVWSD to the TE. Connect the UUT to the test primary TVWSD. The test primary TVWSD shall be configured such that it operates normally in terms of its data exchange with a TVWSDB as emulated by the TE. Connect the UUT to a spectrum analyser.
- c) Switch on the UUT.
- d) Confirm via the test primary TVWSD that the UUT requests specific operational parameters and, if it has not done it before, communicates its device parameters to the TE:
  - 1) The TE then shall respond, via the test primary TVWSD, with operational parameters described in the operational parameter set.
- e) Confirm, via the spectrum analyser, that the UUT transmits in accordance with the operational parameters.
- f) If the UUT total EIRP is greater than the value specified in clause 4.2.7.3.2, confirm that the UUT has communicated channel usage parameters to the test primary TVWSD and that the actual transmissions are in accordance with those parameters.
- g) Wait until the validity of the operational parameters expires and confirm that the UUT stops transmitting according to the operating parameters.

#### 5.4.14.2.2.2 Radiated Measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

#### 5.4.14.2.2.3 Functionality Verification

#### 5.4.14.2.2.3.1 Test method 3

This test verifies the functionalities of a primary TVWSD in support of secondary TVWSDs.

The test method shall be applied in the case where the UUT is a primary TVWSD that supports broadcast of generic operational parameters:

- a) Set the TE to CONFIGURATION3.
- b) Configure the test secondary TVWSD to receive generic operational parameters and to communicate to the primary its device parameters and channel usage parameters.
- c) Switch off the UUT. Switch off the test secondary TVWSD. Connect the UUT to the TE. Connect the test secondary TVWSD to the UUT.
- d) Switch on the UUT. Switch on the test secondary TVWSD.
- e) Confirm that the UUT communicates its device parameters to the TE. Confirm that the UUT requests generic operational parameters:
  - The TE then shall respond with operational parameters for the primary as described in CONFIGURATION3, and with generic operational parameters for the secondaries served by the primary as described in CONFIGURATION3, too.
- f) Confirm via the test secondary TVWSD that the generic operational parameters broadcasted by the UUT are a subset of those in the operational parameter set.
- g) Confirm via the TE that the UUT has reported back to the test TVWSDB the device parameters and the channel usage parameters of the test secondary TVWSD.

#### 5.4.14.2.2.3.2 Test method 4

This test verifies the functionalities of a primary TVWSD in support of secondary TVWSDs.

The test method shall be applied in the case where the UUT is a primary TVWSD that supports provision of specific operational parameters to secondary TVWSDs in its coverage area:

- a) Set the TE to CONFIGURATION3.
- b) Configure the test secondary TVWSD to receive generic operational parameters, to request specific operational parameters (for which it shall communicate its device parameters) and to report back channel usage parameters.
- c) Switch off the UUT. Switch off the test secondary TVWSD. Connect the UUT to the TE. Connect the test secondary TVWSD to the UUT.
- d) Switch on the UUT. Switch on the test secondary TVWSD:
  - The UUT, the test TVWSDB and the test secondary TVWSD will communicate the UUT device
    parameters, the operational parameters for the UUT and the generic operational parameters. The test
    secondary TVWSD will also send a request for specific operational parameters with its own device
    parameters.
- e) Confirm that the UUT communicates the device parameters of the test secondary TVWSD to the test TVWSDB to request specific operational parameters.
- f) Confirm via the test secondary device that the specific operational parameters communicated by the UUT are a subset of those in the operational parameter set.

#### 5.4.15 Geo-location capability

#### 5.4.15.1 Purpose

The objective of this test is to verify that a TVWSD will not continue to transmit with its current operational parameters after its horizontal position has changed by more than  $L_{val}$  meters with respect to its position at the time when this was last reported to the TVWSDB (see clause 4.2.12).

This test applies to all TVWSDs which have geo-location capabilities (and so can request specific operational parameters).

#### 5.4.15.2 Test conditions

See clause 5.2 for the test conditions. These measurements shall be performed at normal test conditions.




Figure 8: Test arrangement for Geo-location capability

If the UUT is a primary TVWSD, the device shall be configured such that it first identifies the test TVWSDB in the TE, and then operates normally in terms of its data exchange with a TVWSDB, which is emulated by the TE (see figure 8). In order to do this, the primary TVWSD shall be configured to communicate with un-authenticated weblisting server and an un-authenticated TVWSDB.

If the UUT is a secondary TVWSD, the UUT shall be configured such that it operates normally in terms of its data exchange with the test primary TVWSD. The test primary TVWSD shall be configured such that it operates normally in terms of its data exchange with a TVWSDB (see figure 5), which is emulated by the TE.

The GNSS signal generator shall be configured to produce the signals corresponding to a position located in a geographical area covered by one of the regulatory domains supported by the UUT.

The TE shall be configured to:

• Let the primary TVWSD communicate with servers on the Internet.

- Act as a web server that replicates the website hosting the weblisting relevant to the regulatory domain chosen
  for the simulated location of the GNSS signal generator. Configure the weblisting to contain only its own test
  TVWSDB server.
- Redirect the request from the primary TVWSD for the weblist to its own webserver, instead of the legitimate server from the regulatory domain where the test takes place.
- Act as a test TVWSDB server and communicate through a protocol that is supported by the primary TVWSD
  under test.
- Emulate the normal operations of a TVWSDB in terms of its data exchange with a primary device.
- Provide operational parameters that are supported by the UUT, as specified by the manufacturer. A value of 50 meters shall be taken for the L<sub>val</sub> parameter. If the UUT is a secondary TVWSD, the TE shall provide generic operational parameters and specific operational parameters. The test primary TVWSD shall provide both sets of parameters.

#### 5.4.15.3 Test method

#### 5.4.15.3.1 Conducted Measurements

The following test method shall be applied to the case where the UUT is a primary TVWSD:

- a) Switch off the UUT. Connect the UUT to the TE. Switch on the UUT. Observe that the UUT consults the TE, communicates to the TE its device parameters including location to requests specific operational parameters and confirm that the TE responds with specific operational parameters.
- b) Configure the TE to respond with a request declined to any additional request for operational parameters.
- c) Change the configuration of the GNSS signal generator to simulate a location that is greater than  $L_{val}$  meters horizontally with respect to its location in step a) above.
- d) Confirm, via the power meter, that the UUT stops transmitting within 60 seconds.

The following test method shall be applied to the case where the UUT is a secondary TVWSD:

- a) Switch off the UUT. Switch off the test primary TVWSD. Connect the test primary TVWSD to the TE. Connect the UUT to the primary TVWSD. Switch on the primary test TVWSD. Switch on the UUT. Observe that the UUT consults the test primary TVWSD and the TE, requests specific operational parameters, and communicates to the TE (via the test primary TVWSD) its device parameters. Confirm that the TE responds with specific operational parameters.
- b) Configure the TE to respond with a request declined to any additional request for specific operational parameters.
- c) Change the configuration of the GNSS signal generator to simulate a location that is greater than  $L_{val}$  meters horizontally with respect to its location in step a) above.
- d) Confirm, via the spectrum analyser, that the UUT stops transmitting in accordance with the specific operational parameters provided for the initial location within 60 seconds.

The UUT may continue transmitting according to the generic operational parameters.

#### 5.4.15.3.2 Radiated Measurements

For radiated measurement, the above test procedure with the test set-up as described in annex B shall be used.

#### 5.4.16 User Access Restrictions

#### 5.4.16.1 Introduction

The aim of this assessment procedure is to verify that for all of the parameters identified in clause 4.2.13.2 it shall not be possible to alter the settings by means of any configuration interface available either on the UUT or on a centralized controller that may be used for networked devices.

#### 5.4.16.2 Assessment conditions

These verifications shall only be performed at normal test conditions (see clause 5.1.2).

The UUT shall operate in its normal operational mode.

For an UUT which requires connection (wired or wireless) to an external device for its configuration, this external device shall be made available to allow the below verification procedure to be performed. The details of this external device shall be described in the test report.

#### 5.4.16.3 Verification Procedure

The UUT's configuration options shall be inspected on all interfaces that the equipment offers for its configuration.

All interfaces in this context includes those provided by any centralized controller whether that be a hardware-based solution or a cloud-based solution. In these cases, all such equipment required to demonstrate these facilities shall be included in this assessment.

It shall be verified by visual inspection of the user manual and all configuration screens available to the user whether there are any commands or settings available to the user, directly or indirectly, which would allow the user to (re-) configure the equipment parameters listed in clause 4.2.13.2 so it is no longer compliant with the requirements of the present document.

The outcome of this assessment procedure shall be recorded in the test report.

## Annex A (informative):

# Relationship between the present document and the essential requirements of Directive 2014/53/EU

The present document has been prepared under the Commission's standardisation request C(2015) 5376 final [i.13] to provide one voluntary means of conforming to the essential requirements of Directive 2014/53/EU on the harmonisation of the laws of the Member States relating to the making available on the market of radio equipment and repealing Directive 1999/5/EC [i.3].

Once the present document is cited in the Official Journal of the European Union under that Directive, compliance with the normative clauses of the present document given in table A.1 confers, within the limits of the scope of the present document, a presumption of conformity with the corresponding essential requirements of that Directive, and associated EFTA regulations.

## Annex B (normative):

## Test sites and arrangements for radiated measurement

#### B.1 Introduction

This annex introduces three most commonly available test sites and a test fixture, to be used in the radiated measurements in accordance with the present document.

Subsequently, the following items are described:

- Open Area Test Site (OATS);
- Semi Anechoic Room (SAR);
- Fully Anechoic Room (FAR);
- Test fixture for relative measurements.

The first three are generally referred to as free field test sites. Both absolute and relative measurements can be performed on these sites. They will be described in clause B.2. Clause B.3 describes the antennas used in these test sites. The test fixture can only be used for relative measurements and will be described in clause B.4.

Where absolute measurements are to be carried out, the chamber should be verified. A detailed verification procedure is described in clause 6 of ETSI TR 102 273-4 [i.9] for the OATS, in clause 6 of ETSI TR 102 273-3 [i.8] for the SAR and in clause 6 of ETSI TR 102 273-2 [i.7] for the FAR.

Information for calculating the measurement uncertainty of measurements on one of these test sites can be found in ETSI TR 100 028-1 [i.4], ETSI TR 100 028-2 [i.5], ETSI TR 102 273-2 [i.7], ETSI TR 102 273-3 [i.8] and ETSI TR 102 273-4 [i.9].

## B.2 Radiation test sites

## B.2.1 Open Area Test Site (OATS)

An Open Area Test Site comprises a turntable at one end and an antenna mast of variable height at the other end above a ground plane which, in the ideal case, is perfectly conducting and of infinite extent. In practice, while good conductivity can be achieved, the ground plane size has to be limited. A typical Open Area Test Site is shown in figure B.1.




Figure B.1: A typical Open Area Test Site (OATS)

The ground plane creates a wanted reflection path, such that the signal received by the receiving antenna is the sum of the signals received from the direct and reflected transmission paths. The phasing of these two signals creates a unique received level for each height of the transmitting antenna (or UUT) and the receiving antenna above the ground plane.

The antenna mast provides a variable height facility (from 1 m to 4 m) so that the position of the measurement antenna can be optimized for maximum coupled signal between antennas or between a UUT and the measurement antenna.

A turntable is capable of rotation through  $360^{\circ}$  in the horizontal plane and it is used to support the test sample (UUT) at a specified height, usually 1,5 m above the ground plane.

The measurement distance and minimum chamber dimensions can be found in clause B.2.4. The distance used in actual measurements shall be recorded with the test results.

Further information on Open Area Test Sites can be found in ETSI TR 102 273-4 [i.9].

#### B.2.2 Semi Anechoic Room

A Semi Anechoic Room is - or anechoic chamber with a conductive ground plane is - an enclosure, usually shielded, whose internal walls and ceiling are covered with radio absorbing material. The floor, which is metallic, is not covered by absorbing material and forms the ground plane. The chamber usually contains an antenna mast at one end and a turntable at the other end. A typical anechoic chamber with a conductive ground plane is shown in figure B.2.

This type of test chamber attempts to simulate an ideal Open Area Test Site, whose primary characteristic is a perfectly conducting ground plane of infinite extent.




Figure B.2: A typical Semi Anechoic Room

In this facility the ground plane creates a wanted reflection path, such that the signal received by the receiving antenna is the sum of the signals received from the direct and reflected transmission paths. The phasing of these two signals creates a unique received level for each height of the transmitting antenna (or UUT) and the receiving antenna above the ground plane.

The antenna mast provides a variable height facility (from 1 m to 4 m) so that the position of the measurement antenna can be optimized for maximum coupled signal between antennas or between a UUT and the measurement antenna.

A turntable is capable of rotation through  $360^{\circ}$  in the horizontal plane and it is used to support the test sample (UUT) at a specified height, usually 1,5 meters above the ground plane.

The measurement distance and minimum chamber dimensions can be found in clause B.2.4. The distance used in actual measurements shall be recorded with the test results.

Further information on Semi Anechoic Rooms can be found in ETSI TR 102 273-3 [i.8].

## B.2.3 Fully Anechoic Room (FAR)

A Fully Anechoic Room is an enclosure, usually shielded, whose internal walls, floor and ceiling are covered with radio absorbing material. The chamber usually contains an antenna support at one end and a turntable at the other end. A typical Fully Anechoic Room is shown in figure B.3.




Figure B.3: A typical Fully Anechoic Room

The chamber shielding and radio absorbing material work together to provide a controlled environment for testing purposes. This type of test chamber attempts to simulate free space conditions.

The shielding provides a test space, with reduced levels of interference from ambient signals and other outside effects, whilst the radio absorbing material minimizes unwanted reflections from the walls and ceiling which can influence the measurements. The shielding should be sufficient to eliminate interference from the external environment that would mask any signals that have to be measured.

A turntable is capable of rotation through  $360^{\circ}$  in the horizontal plane and it is used to support the UUT at a suitable height (e.g. 1 m) above the ground plane.

The measurement distance and minimum chamber dimensions can be found in clause B.2.4. The distance used in actual measurements shall be recorded with the test results.

Further information on Fully Anechoic Rooms can be found in ETSI TR 102 273-2 [i.7].

## B.2.4 Measurement Distance

The measurement distance should be chosen in order to measure the UUT at far-field conditions. The minimum measurement distance between the equipment and the measurement antenna should be  $\lambda$  or  $r_{m>>}$   $\frac{D^2}{\lambda}$ , whichever is the greater.

 $\lambda$  = wavelength in m

 $r_{m}$  = minimum measurement distance between UUT and measurement antenna in m

D = largest dimension of physical aperture of the largest antenna in the measurement setup, in m

 $\frac{D^2}{\lambda}$  = distance between outer boundary of radiated near field (Fresnel region) and inner boundary of the radiated far-field (Fraunhofer region) in m, also known as Rayleigh distance

For those measurements, where these conditions cannot be fulfilled and where the measurement distance would result in measurements in the near field (e.g. while measuring spurious emissions), this should be noted in the test report and the additional measurement uncertainty should be incorporated into the results.

### B.3 Antennas

## B.3.1 Antenna types

Antennas are needed for the radiated measurements on the three test sites described in clause B.2. Depending on its use, the antenna will be designated as "measurement antenna" or "substitution antenna".

#### B.3.2 Measurement antenna

In emission tests the measurement antenna is used to detect the field from the UUT in one stage of the measurement, and from the substitution antenna in the other stage. When the test site is used for the measurement of receiver characteristics, the antenna is used as the transmitting device.

The measurement antenna should be mounted on a support capable of allowing the antenna to be used in either horizontal or vertical polarization. Additionally, on an OATS or SAR, the height of the centre of the antenna above the ground should be variable over the specified range (usually 1 m to 4 m).

In the frequency band 30 MHz to 1 000 MHz, biconical or Logarithmic Periodic Dipole Antennas (LPDA) are recommended. Above 1 GHz, horn antennas or logarithmic periodic dipole antennas are recommended.

For spurious emission testing, however, a combination of biconical antennas (commonly termed "bicones") and log periodic dipole array antennas (commonly termed "log periodics") could be used to cover the entire 30 MHz to 1 000 MHz band.

The measurement antenna does not require an absolute calibration.

#### B.3.3 Substitution antenna

The substitution antenna shall be used to replace the equipment under test in substitution measurements.

The substitution antenna shall be suitable for the frequency range and the return loss of the antenna shall be taken into account when calculating the measurement uncertainty.

The phase centre of this antenna shall coincide with the reference point of the test sample it has replaced. Therefore antennas with a phase centre that changes as a function of frequency (such as a LPDA) are not suitable as a substitution antenna.

The reference point of the substitution antenna shall coincide with the volume centre of the UUT when its antenna is internal, or the point where an external antenna is connected to the UUT.

The distance between the lower extremity of the antenna and the ground shall be at least 30 cm.

The substitution antenna shall be calibrated for the test site (OATS, SAR, FAR) in which it will be used. For below 1 GHz, the calibration is relative to a half wave dipole, while above 1 GHz, an isotropic radiator is the reference.

Calibration figures intended for use above a reflective surface cannot be used in an anechoic chamber or vice versa.

## B.4 Test fixture

#### B.4.1 Conducted measurements and use of test fixture

In view of the low power levels of the equipment to be tested under the present document, conducted measurements may be applied to equipment provided with a (temporary) antenna connector, e.g. by means of a spectrum analyser.

In the case of equipment intended for use with an integral antenna and no external (temporary) antenna connectors are provided, a test fixture suitable to allow relative measurements to be made on the UUT may be used at least for the measurements at the extremes of temperature.

## B.4.2 Description of the test fixture

The test fixture shall provide a means of coupling to the radio frequency output(s).

The impedance of the external connection to the test fixture shall be 50  $\Omega$  at the working frequencies of the equipment.

The performance characteristics of this test fixture under normal and extreme conditions shall be such that:

- a) the coupling loss shall be limited to ensure a sufficient dynamic range of the setup;
- b) the variation of coupling loss with frequency shall not cause errors exceeding 2 dB in measurements using the test fixture;
- c) the coupling device shall not include any non-linear elements.

## B.4.3 Using the test fixture for relative measurements

Step 1 to step 4 below describe the principle for performing relative measurements for those requirements where testing needs to be repeated at the extremes of the temperature.

#### Step 1:

Perform the measurement under normal conditions on a test site for radiated measurements as described in annex B, clause B.1. This will result in an absolute value for the requirement being tested. This value shall be recorded.

#### Step 2:

Put the equipment with the test fixture in the temperature chamber. Perform the same measurement at normal conditions in this environment and normalize the measuring equipment to get the same reading as before in step 1.

#### **Step 3:**

Take care that the environment is time invariant (fixed coupling).

#### Step 4:

Change the temperature in the temperature chamber and perform the measurement again. Due to the normalization done in step 2, the result will be the value for this requirement at the extreme condition.

## B.4.4 Using the test fixture for normalized measurements

The different steps below describe the procedure for performing normalized measurements.

#### Step 1:

A reference measurement for the *RF output power* of the UUT (without test fixture) shall be performed on a test site for radiated measurements as described in clause B.2. This will result in a reference value to be used for the normalization.

#### Step 2:

Place the UUT in the test fixture. The position of the UUT in the test fixture shall remain unchanged for the total duration of the test procedure including the normalization and the measurement.

#### Step 3:

Perform the RF output power measurement without correction factors for coupling.

#### Step 4:

Calculate the coupling loss of the test fixture by comparing the measurements from Step 1 and Step 3. The resulting coupling loss value shall only be used for in band measurements and for the measurement of Receiver Blocking. Ensure that the RF coupling accuracy remains within the range specified in clause B.4.2, item b).

## B.4.5 Using the test fixture for level independent measurements

The procedure below describes how to perform level independent fixture measurements.

Put the equipment in the test fixture. Perform the applicable measurement as further described in its relevant clause in clause 5 without correction factors for coupling loss.

As an alternative to the procedure above, the procedure described in clause B.4.4 (using the normalization) can be used.

## B.5 Guidance on the use of radiation test sites

## B.5.1 Test procedures, equipment and verification

Clause B.5 details procedures, test equipment arrangements and verification that should be carried out before any of the radiated test are undertaken. These schemes are common to all types of test sites described in clause B.2.

Where necessary, a mounting bracket of minimal size should be available for mounting the UUT on the turntable. This bracket should be made from low conductivity, low relative permittivity (i.e.  $\frac{\varepsilon}{\varepsilon_0}$  < 1,5) material(s) such as expanded polystyrene, balsawood, etc.

## B.5.2 Power supplies for the battery powered UUT

All tests should be performed using power supplies wherever possible, including tests on UUT designed for battery-only use. For battery powered equipment, power leads should be connected to the UUT's supply terminals (and monitored with a digital voltmeter) but the battery should remain present, electrically isolated from the rest of the equipment, possibly by putting tape over its contacts.

The presence of these power cables can, however, affect the measured performance of the UUT. For this reason, they should be made to be "transparent" as far as the testing is concerned. This can be achieved by routing them away from the UUT and down to the either the screen, ground plane or facility wall (as appropriate) by the shortest possible paths. Precautions should be taken to minimize pick-up on these leads (e.g. the leads could be twisted together, loaded with ferrite beads at 0,15 m spacing or otherwise loaded).

## B.5.3 Site preparation

The cables to the measuring and substitution antenna should be routed horizontally away from the testing area for a minimum of 2 m (unless, in the case both types of anechoic chamber, a back wall is reached) and then allowed to drop vertically and out through either the ground plane or screen (as appropriate) to the test equipment. Precautions should be taken to minimize pick up on these leads (e.g. dressing with ferrite beads, or other loading). The cables, their routing and dressing should be identical to the verification set-up.

NOTE: For ground reflection test sites (i.e. anechoic chambers with ground planes and Open Area Test Sites) which incorporate a cable drum with the antenna mast, the 2 m requirement may be impossible to comply with.

Calibration data for all items of test equipment should be available and valid. For test, substitution and measuring antennas, the data should include gain relative to an isotropic radiator (or antenna factor) for the frequency of test. Also, the VSWR of the substitution and measuring antennas should be known.

The calibration data on all cables and attenuators should include insertion loss and VSWR throughout the entire frequency range of the tests. All VSWR and insertion loss figures should be recorded in the log book results sheet for the specific test.

Where correction factors/tables are required, these should be immediately available.

For all items of test equipment, the maximum errors they exhibit should be known along with the distribution of the error e.g.:

- cable loss:  $\pm 0.5$  dB with a rectangular distribution;
- measuring receiver: 1,0 dB (standard deviation) signal level accuracy with a Gaussian error distribution.

At the start of measurements, system checks should be made on the items of test equipment used on the test site.

## B.6 Coupling of signals

#### B.6.1 General

The presence of leads in the radiated field may cause a disturbance of that field and lead to additional measurement uncertainty. These disturbances can be minimized by using suitable coupling methods, offering signal isolation and minimum field disturbance (e.g. optical coupling).

## B.6.2 Data Signals

Isolation can be provided by the use of optical, ultrasonic or infra-red means. Field disturbance can be minimized by using a suitable fibre optic connection. Ultrasonic or infra-red radiated connections require suitable measures for the minimization of ambient noise.

## Annex C (normative): Procedures for radiated measurements

## C.1 Introduction


This annex gives the general procedures for radiated measurements using the test sites and arrangements described in annex B.

Preferably, radiated measurements shall be performed in a FAR, see clause C.3. Radiated measurements in an OATS or SAR are described in clause C.2.

## C.2 Radiated measurements in an OATS or SAR

Radiated measurements shall be performed with the aid of a measurement antenna and a substitution antenna, in test sites described in annex B. The measurement set-up shall be calibrated according to the procedure defined in the present annex. The UUT and the measurement antenna shall be oriented such as to obtain the maximum emitted power level. This position shall be recorded in the measurement report.

- a) The measurement antenna (device 2 in figure C.1) shall be oriented initially for vertical polarization unless otherwise stated and the UUT (device 1 in figure C.1) shall be placed on the support in its standard position and switched on.
- b) The measurement equipment (device 3 in figure C.1) shall be connected to the measurement antenna and set-up according to the specifications of the test.

- c) The UUT shall be rotated through 360° in a horizontal plane until a higher maximum signal is received.
- d) The measurement antenna shall be raised or lowered again through the specified height range until a maximum is obtained. This level shall be recorded. This maximum may be a lower value than the value obtainable at heights outside the specified limits.
- e) This measurement procedure in step c) and step d) above shall be repeated for horizontal polarization.

## C.3 Radiated measurements in a FAR

For radiated measurements using a FAR, the procedure is identical to the one described in clause C.2, except that the height scan in step d) is omitted.

## C.4 Substitution measurement

To determine the absolute measurement value a substitution measurement is performed. The following steps have to be performed:

- 1) Replacing the UUT with the substitution antenna that is depicted as device 1 in figure C.1. The substitution antenna shall have vertical polarization.
- 2) Connect a signal generator to the substitution antenna, and adjust it to the measurement frequency.
- 3) If an OATS or a SAR is used, the measurement antenna height shall be varied within the range provided in figure C.1, to ensure that the maximum signal is received.
- 4) Subsequently, the power of the signal generator is adjusted until the same level is obtained again at the measurement equipment.
- 5) The radiated power is equal to the power supplied by the signal generator, increased with the substitution antenna gain minus the cable losses (values in dB).
- 6) This measurement procedure described in step 2) to step 5) above shall be repeated with horizontal polarization for the substitution antenna.

For test sites with a fixed setup of the measurement antenna(s) and a reproducible positioning of the UUT, correction values from a verified site calibration can be used alternatively.

# Annex D (informative): Maximum Measurement Uncertainty

The measurements described in the present document are based on the following assumptions:

- the measured value related to the corresponding limit is used to decide whether an equipment meets the requirements of the present document;
- the value of the measurement uncertainty for the measurement of each parameter is included in the test report.

Table D.1 shows the recommended values for the maximum measurement uncertainty figures.

## Annex E (informative): Nominal Channel Bandwidth and Total Bandwidth

A nominal channel is defined as one or more DTT channels that are used by a TVWSD for its wanted transmissions. The lower and upper edge frequencies of a nominal channel are specified by the TVWSDB and are expected to coincide with the European harmonised DTT channel raster shown in figure E.1.



The nominal channel bandwidth is the widest band of frequencies assigned to a single channel. In the case of TVWSDs a single channel will be 8 MHz or a multiple of 8 MHz, which may be contiguous or non-contiguous.

A device may transmit in a single DTT channel at any given time, or it may transmit simultaneously in a group of contiguous DTT channels, multiple non-contiguous DTT channels, or a mixture of contiguous and non-contiguous DTT channels.


Where a TVWSD transmits in a single DTT channel, it will be considered to have a single nominal channel with a bandwidth of 8 MHz, see figure E.2.



NOTE: Nominal channel bandwidth is 8 MHz.

Figure E.2: Single DTT channel


Where a TVWSD transmits simultaneously in a group of contiguous DTT channels, it will be considered to have a single nominal channel with a nominal channel bandwidth which is the sum of the individual DTT channel bandwidths (i.e. a multiple of 8 MHz), see figure E.3.



NOTE: Nominal channel bandwidth is 24 MHz. The total nominal channel bandwidth is also 24 MHz.

Figure E.3: Group of contiguous DTT channels


Where a TVWSD transmits simultaneously in multiple non-contiguous DTT channels, it will be considered to have multiple nominal channels each with a nominal channel bandwidth of 8 MHz; i.e. each nominal channel will be considered separately, see figure E.4.



NOTE: Nominal channel bandwidth is 8 MHz. The total nominal channel bandwidth is 24 MHz.

Where a TVWSD transmits simultaneously in a mixture of contiguous and non-contiguous DTT channels, each group of contiguous DTT channels will be considered as a single nominal channel, see figure E.5.



NOTE: Nominal channel bandwidths are 8 MHz and 24 MHz. The total nominal channel bandwidth is 40 MHz.

Figure E.5: Mixture of contiguous and non-contiguous DTT channels

In each of the above cases, the *total* nominal channel bandwidth is equal to the sum of the individual nominal channel bandwidths.

NOTE: The signal power within a nominal channel is referred to as in-block power. The signal power outside a nominal channel is referred to as out-of-block power. The *total* in-block power is the sum (in watts) of the powers in each nominal channel.
