

## 1 Scope

The present document specifies the network Test Suite Structure and Test Purposes (TSS&TP) for the  $T_B$  reference point or coincident  $S_B$  and  $T_B$  reference point (as defined in ITU-T Recommendation I.413 [5]) of implementations conforming to the standards for the signalling user-network layer 3 specification for ATM traffic descriptor modification with negotiation by the connection owner of the Digital Subscriber Signalling System No. 2 (DSS2) protocol for the pan-European Broadband Integrated Services Digital Network (B-ISDN), EN 301 486-1 [3].

A further part of the present document specifies the Abstract Test Suite (ATS) and partial Protocol Implementation eXtra Information for Testing (PIXIT) proforma based on the present document.

## 5 Test Purposes (TP)

### 5.1 Introduction

The procedures for ATM traffic descriptor modification with negotiation by the connection owner are based on the modification procedures of EN 301 003-1 [8]. Therefore the test purposes defined in EN 301 003-3 [9] apply. Consequently, only for test requirements in addition to the requirements of EN 301 003-1 [8] TPs are defined.

## 5.1.1 TP naming convention

TPs are numbered, starting at 01, within each group. Groups are organized according to the TSS. Additional references are added to identify the actual test suite (see table 1).

## 5.1.2 Source of TP definition

The TPs are based on EN 301 486-1 [3].

## 5.1.3 Test strategy

As the base standard EN 301 486-1 [3] contains no explicit requirements for testing, the TPs were generated as a result of an analysis of the base standard and the PICS specification EN 301 486-2 [4].

The TPs are only based on conformance requirements related to the externally observable behaviour of the IUT, and are limited to conceivable situations to which a real implementation is likely to be faced (ETS 300 406 [1]).

#### 5.1.4 Test of call states

Many TPs include a reference to the IUT's final call state after the realization of the TP. In these cases the TP includes the requirement to ensure that the IUT has entered this particular final call state. Ensuring that the IUT is in a particular call state shall be realized by following the procedures described in clause 5.6.11 of EN 300 443-1 [2]. According to these procedures, the IUT on receipt of a STATUS ENQUIRY message, shall respond with a STATUS message indicating, in the fifth octet of the Call state information element, the current call state of the IUT. This exchange of messages is not mentioned explicitly in each TP but is considered to be implicit in the reference to the final call state. This way of phrasing the TPs has been used to avoid over-complicating the text and structure of the TPs and to improve the readability.

# 5.2 TPs for the ATM traffic descriptor modification with negotiation, user

All PICS items referred to in this clause are as specified in EN 301 486-2 [4] unless indicated otherwise by another numbered reference.

Unless specified:

- the messages indicated are valid and contain at least the mandatory information elements and possibly optional information elements;
- the information elements indicated are valid and contain at least the mandatory parameters and possibly optional parameters.

# 5.2.1 Signalling procedures at the coincident $S_B/T_B$ and at the $T_B$ reference points

#### 5.2.1.1 Modification/Negotiation procedures at the requesting entity

Selection: The IUT support the requirements for the modification requesting entity. PICS: R 2.1.

## 5.2.1.1.1 Modification/Negotiation request (01)

Test purposes for EN 301 486-1 [3] clause 9.1.1.

#### AMNN\_01\_01

Ensure that the IUT in N10, to indicate the arrival of a modification request with negotiation of the traffic parameters (including an acceptable ATM traffic descriptor information element and an acceptable minimum acceptable ATM traffic descriptor information element),

sends a MODIFY REQUEST message with both the ATM traffic descriptor information element and the minimum acceptable ATM traffic descriptor information element included and enters N13.

#### AMNN\_01\_02

Ensure that the IUT in N10, to indicate the arrival of a modification request with negotiation of the traffic parameters (including an acceptable ATM traffic descriptor information element and an acceptable alternative ATM traffic descriptor information element),

sends a MODIFY REQUEST message with both the ATM traffic descriptor information element and the alternative ATM traffic descriptor information element included and enters N13.

#### 5.2.1.1.2 Modification/Negotiation acceptance (02)

Test purposes for EN 301 486-1 [3] clause 9.1.2.

#### **AMNN 02 01**

Ensure that the IUT in N13 (having sent a MODIFY REQUEST message with the alternative ATM traffic descriptor information element), on receipt of a MODIFY ACKNOWLEDGE message including an acceptable ATM traffic descriptor information element,

sends no message (and passes this ATM traffic descriptor information element in a MODIFY ACKNOWLEDGE message at the remote interface) and enters N10.

#### AMNN 02 02

Ensure that the IUT in N13 (having sent a MODIFY REQUEST message with the minimum acceptable ATM traffic descriptor information element), on receipt of a MODIFY ACKNOWLEDGE message including an acceptable ATM traffic descriptor information element,

sends no message (and passes this ATM traffic descriptor information element in a MODIFY ACKNOWLEDGE message at the remote interface) and enters N10.

#### **AMNN 02 03**

Ensure that the IUT in N13 (having sent a MODIFY REQUEST message with the alternative ATM traffic descriptor information element), on receipt of a MODIFY ACKNOWLEDGE message without ATM traffic descriptor information element,

sends no message (and passes the ATM traffic descriptor information element originally sent in the MODIFY REQUEST message in a MODIFY ACKNOWLEDGE message at the remote interface) and enters N10.

#### **AMNN 02 04**

Ensure that the IUT in N13 (having sent a MODIFY REQUEST message with the minimum acceptable ATM traffic descriptor information element), on receipt of a MODIFY ACKNOWLEDGE message without ATM traffic descriptor information element,

sends no message (and passes the ATM traffic descriptor information element originally sent in the MODIFY REQUEST message in a MODIFY ACKNOWLEDGE message at the remote interface) and enters N10.

#### AMNN\_02\_05

Ensure that the IUT in N13, on receipt of a MODIFY ACKNOWLEDGE message with an ATM traffic descriptor information element ( $IE_flag = 0$ ) including a different set of parameters as contained in the ATM traffic descriptor information element of the MODIFY REQUEST message,

sends no message or optionally sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N10 (and passes this ATM traffic descriptor information element originally sent in the MODIFY REQUEST message in a MODIFY ACKNOWLEDGE message at the remote interface) and enters N10.

#### AMNN 02 06

Ensure that the IUT in N13, on receipt of a MODIFY ACKNOWLEDGE message with an ATM traffic descriptor information element (IE\_flag = 1, IE\_AI = clear call) including a different set of parameters as contained in the ATM traffic descriptor information element of the MODIFY REQUEST message,

sends a RELEASE message with a Cause information element indicating a cause value 100 "invalid information element contents" and enters N12.

#### **AMNN 02 07**

Ensure that the IUT in N13, on receipt of a MODIFY ACKNOWLEDGE message with an ATM traffic descriptor information element (IE\_flag = 1, IE\_AI = discard message and report status) including a different set of parameters as contained in the ATM traffic descriptor information element of the MODIFY REQUEST message,

sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N13 (and passes no message at the remote interface) and remains in N13.

#### **AMNN 02 08**

Ensure that the IUT in N13, on receipt of a MODIFY ACKNOWLEDGE message with an ATM traffic descriptor information element (IE\_flag = 1, IE\_AI = discard message) including a different set of parameters as contained in the ATM traffic descriptor information element of the MODIFY REQUEST message,

sends no message (and passes no message at the remote interface) and remains in N13.

#### AMNN 02 09

Ensure that the IUT in N13, on receipt of a MODIFY ACKNOWLEDGE message with an ATM traffic descriptor information element (IE\_flag = 1, IE\_AI = discard information element, proceed and report status) including a different set of parameters as contained in the ATM traffic descriptor information element of the MODIFY REQUEST message, sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N10 (and passes this ATM traffic descriptor information element originally sent in the MODIFY REQUEST message in a MODIFY ACKNOWLEDGE message at the remote interface) and enters N10.

#### **AMNN 02 10**

Ensure that the IUT in N13, on receipt of a MODIFY ACKNOWLEDGE message with an ATM traffic descriptor information element (IE\_flag = 1, IE\_AI = discard information element and proceed) including a different set of parameters as contained in the ATM traffic descriptor information element of the MODIFY REQUEST message, sends no message (and passes this ATM traffic descriptor information element originally sent in the MODIFY REQUEST message in a MODIFY ACKNOWLEDGE message at the remote interface) and enters N10.

#### 5.2.1.2 Modification/Negotiation procedures at the responding entity

**Selection:** The IUT support the requirements for the modification requesting entity. PICS: R 2.2.

#### 5.2.1.2.1 Modification/Negotiation confirmation (03)

Test purposes for EN 301 486-1 [3] clause 9.2.

#### **AMNN 03 01**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with acceptable traffic parameters included in the ATM traffic descriptor information element and with acceptable traffic parameters included in the alternative ATM traffic descriptor information element,

accepts the message (resulting in sending a MODIFY REQUEST message including both the ATM traffic descriptor information element and the alternative ATM traffic descriptor information element at the remote interface) and enters N14.

#### AMNN\_03 02

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with acceptable traffic parameters included in the ATM traffic descriptor information element and with acceptable traffic parameters included in the minimum acceptable ATM traffic descriptor information element,

accepts the message (resulting in sending a MODIFY REQUEST message including both the ATM traffic descriptor information element and the minimum acceptable ATM traffic descriptor information element at the remote interface) and enters N14.

#### **AMNN 03 03**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with unacceptable traffic parameters included in the ATM traffic descriptor information element and acceptable traffic parameters included in the alternative ATM traffic descriptor information element,

accepts the message (resulting in sending a MODIFY REQUEST message including an ATM traffic descriptor information element with the adapted traffic parameters at the remote interface) and enters N14.

#### **AMNN 03 04**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with unacceptable traffic parameters included in the ATM traffic descriptor information element and traffic parameters included in the minimum acceptable ATM traffic descriptor information element such, that the IUT is able to provide traffic rates between the two sets of values.

accepts the message (resulting in sending a MODIFY REQUEST message including the ATM traffic descriptor information element with the adapted traffic parameters and a minimum acceptable ATM traffic descriptor information element with traffic parameters which are still less than the corresponding parameter in the modified ATM traffic descriptor information element at the remote interface) and enters N14.

#### **AMNN 03 05**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with unacceptable traffic parameters included in the ATM traffic descriptor information element and acceptable traffic parameters included in the minimum acceptable ATM traffic descriptor information element which are the highest values the IUT is able to support,

accepts the message (resulting in sending a MODIFY REQUEST message including the ATM traffic descriptor information element containing traffic parameters, values of modified ones equal to traffic parameter values in the received minimum acceptable ATM traffic descriptor information element at the remote interface) and enters N14.

#### **AMNN 03 06**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with unacceptable traffic parameters included in the ATM traffic descriptor information element and unacceptable traffic parameters included in the minimum acceptable ATM traffic descriptor information element,

sends a MODIFY REJECT message with a Cause information element indicating a cause value 37 "user cell rate unavailable" and re-enters N10.

#### **AMNN 03 07**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with unacceptable traffic parameters included in the ATM traffic descriptor information element and unacceptable traffic parameters included in the alternative ATM traffic descriptor information element,

sends a MODIFY REJECT message with a Cause information element indicating a cause value 37 "user cell rate unavailable" and re-enters N10.

#### **AMNN 03 08**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with both alternative ATM traffic descriptor information element, and minimum acceptable ATM traffic descriptor information element included,

sends a MODIFY REJECT message with a Cause information element indicating a cause value 73 "unsupported combination of traffic parameters" and re-enters N10.

#### **AMNN 03 09**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and an alternative ATM traffic descriptor information element ( $IE_flag = 0$ ) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends no message or optionally sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N14 (resulting in sending a MODIFY REQUEST message including only the ATM traffic descriptor information element at the remote interface) and enters N14.

#### **AMNN 03 10**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and an alternative ATM traffic descriptor information element (IE\_flag = 1, IE\_AI = clear call) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends a RELEASE message with a Cause information element indicating a cause value 100 "invalid information element contents" and enters N12.

#### **AMNN 03 11**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and an alternative ATM traffic descriptor information element (IE\_flag = 0, IE\_AI = discard message and report status) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N10 (and passes no message at the remote interface) and remains in N10.

#### AMNN\_03\_12

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and an alternative ATM traffic descriptor information element (IE\_flag = 0, IE\_AI = discard message) containing traffic parameters increased compared to those in the ATM traffic descriptor information element, sends no message (and passes no message at the remote interface) and remains in N10.

#### **AMNN 03 13**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and an alternative ATM traffic descriptor information element (IE\_flag = 0, IE\_AI = discard information element, proceed and report status) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N14 (resulting in sending a MODIFY REQUEST message including only the ATM traffic descriptor information element at the remote interface) and enters N14.

#### AMNN\_03\_14

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and an alternative ATM traffic descriptor information element (IE\_flag = 0, IE\_AI = discard information element and proceed) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends no message (resulting in sending a MODIFY REQUEST message including only the ATM traffic descriptor information element at the remote interface) and enters N14.

#### **AMNN 03 15**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and a minimum acceptable ATM traffic descriptor information element (IE\_flag = 0) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends no message or optionally sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N14 (resulting in sending a MODIFY REQUEST message including only the ATM traffic descriptor information element at the remote interface) and enters N14.

#### **AMNN 03 16**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and a minimum acceptable ATM traffic descriptor information element (IE\_flag = 1, IE\_AI = clear call) containing traffic parameters increased compared to those in the ATM traffic descriptor information element, sends a RELEASE message with a Cause information element indicating a cause value 100 "invalid information".

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and a minimum acceptable ATM traffic descriptor information element (IE\_flag = 0, IE\_AI = discard message) containing traffic parameters increased compared to those in the ATM traffic descriptor information element, sends no message (and passes no message at the remote interface) and remains in N10.

#### AMNN\_03\_19

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and a minimum acceptable ATM traffic descriptor information element (IE\_flag = 0, IE\_AI = discard information element, proceed and report status) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends a STATUS message with a Cause information element indicating a cause value 100 "invalid information element contents" and with a Call state information element indicating N14 (resulting in sending a MODIFY REQUEST message including only the ATM traffic descriptor information element at the remote interface) and enters N14.

#### **AMNN 03 20**

Ensure that the IUT in N10, on receipt of a MODIFY REQUEST message with an ATM traffic descriptor information element and a minimum acceptable ATM traffic descriptor information element (IE\_flag = 0, IE\_AI = discard information element and proceed) containing traffic parameters increased compared to those in the ATM traffic descriptor information element,

sends no message (resulting in sending a MODIFY REQUEST message including only the ATM traffic descriptor information element at the remote interface) and enters N14.

## 6 Compliance

An ATS which complies with this TSS&TP specification shall:

- a) consist of a set of test cases corresponding to the set or to a subset of the TPs specified in clause 5;
- b) use a TSS which is an appropriate subset of the whole of the TSS specified in clause 4;
- c) use the same naming conventions for the test groups and test cases;
- d) maintain the relationship specified in clause 5 between the test groups and TPs and the entries in the PICS proforma to be used for test case deselection;
- e) comply with ISO/IEC 9646-2 [7].

In the case of a) or b) above, a subset shall be used only where a particular Abstract Test Method (ATM) makes some TPs untestable. All testable TPs from clause 5 shall be included in a compliant ATS.

## 7 Requirements for a comprehensive testing service

As a minimum the Remote test method, as specified in ISO/IEC 9646-2 [7], shall be used by any organization claiming to provide a comprehensive testing service for network equipment claiming conformance to EN 301 486-1 [3].
