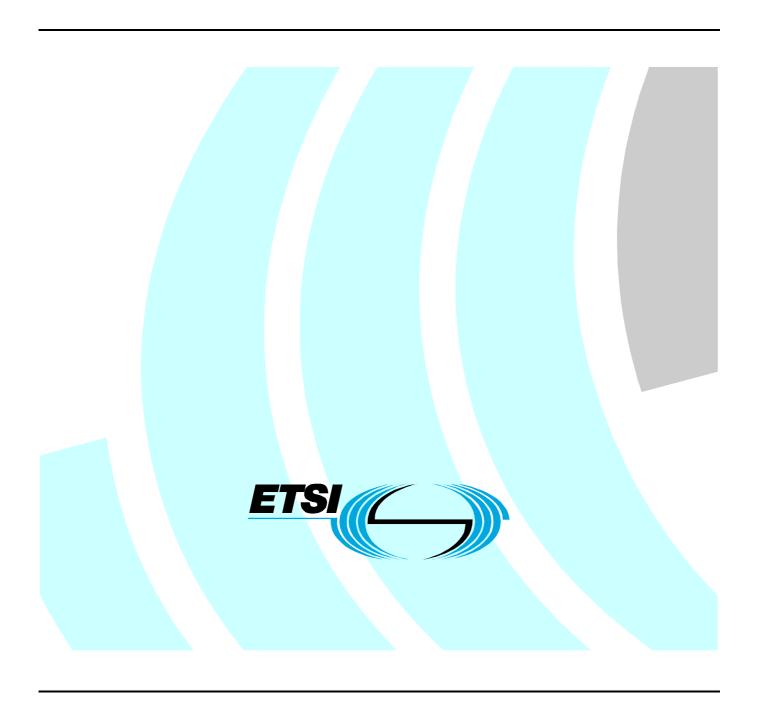

## 1 Scope

The present document specifies the user Test Suite Structure and Test Purposes (TSS&TP) for the  $T_B$  reference point or coincident  $S_B$  and  $T_B$  reference point (as defined in ITU-T Recommendation I.413 [5]) of implementations conforming to the standards for the Broadband Integrated Services Digital Network (B-ISDN) Digital Subscriber Signalling System No. two (DSS2) protocol specification for support of Quality of Service Class and parameters indication at call/connection establishment defined in EN 301 815-1 [1].

A further part of the present document specifies the Abstract Test Suite (ATS) and partial Protocol Implementation eXtra Information for Testing (PIXIT) proforma based on the present document.

## 5 Test Purposes (TP)

#### 5.1 Introduction

For each test requirement a TP is defined.

## 5.1.1 TP naming convention

TPs are numbered, starting at 01, within each group. Groups are organized according to the TSS. Additional references are added to identify the actual test suite (see table 1).

#### 5.1.2 Source of TP definition

The TPs are based on EN 301 815-1 [1].

## 5.1.3 Test strategy

As the base standard EN 301 815-1 [1] contains no explicit requirements for testing, the TPs were generated as a result of an analysis of the base standard and the PICS specification EN 301 815-2 [2].

The TPs are only based on conformance requirements related to the externally observable behaviour of the IUT and are limited to conceivable situations to which a real implementation is likely to be faced (see ETS 300 406 [6]).

#### 5.1.4 Test of call states

Many TPs include a reference to the IUT's final call state after the realization of the TP. In these cases the TP includes the requirement to ensure that the IUT has entered this particular final call state. Ensuring that the IUT is in a particular call state shall be realized by following the procedures described in clause 5.6.11 of EN 300 443-1 [7]. According to these procedures, the IUT on receipt of a STATUS ENQUIRY message, shall respond with a STATUS message indicating, in the fifth octet of the Call state information element, the current call state of the IUT. This exchange of messages is not mentioned explicitly in each TP but is considered to be implicit in the reference to the final call state. This way of phrasing the TPs has been used to avoid over-complicating the text and structure of the TPs and to improve the readability.

# 5.2 TPs for the Quality of Service Class and Parameters indication, user

All PICS items referred to in this clause are as specified in EN 301 815-2 [2] unless indicated otherwise by another numbered reference.

Unless specified:

- the messages indicated are valid and contain at least the mandatory information elements and possibly optional information elements:
- the information elements indicated are valid and contain at least the mandatory parameters and possibly optional parameters.

#### 5.2.1 Support of Quality of Service classes (01)

Test purposes for EN 301 815-1 [1] (ITU-T Recommendation Q.2965.1 [8], modified).

#### QOSU\_01\_01

Ensure that the IUT in U0, to initiate call establishment.

sends a SETUP message (Quality of Service parameter indicating identical forward and backward QoS classes, Broadband bearer capability, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters) and enters U1.

**Selection:** Outgoing calls with QoS class indication supported. PICS: MCu 1

#### OOSU 01 02

Ensure that the IUT in U0, on receipt of a SETUP message (Valid combination of traffic parameters, Quality of Service parameter present, requesting a QOS class that is supported),

sends any of a CALL PROCEEDING, ALERTING or CONNECT message and enters the relevant call state U9, U7 or U8.

**Selection:** Incoming calls with QoS class interpretation supported. PICS: MCu 2

#### QOSU\_01\_03

Ensure that the IUT in U0, on receipt of a SETUP message (Valid combination of traffic parameters, Quality of Service parameter present, requesting a QOS class that is not supported),

sends a RELEASE COMPLETE message (Cause value = 49) and remains in U0.

**Selection:** Incoming calls with QoS class interpretation supported. PICS: MCu 2

#### QOSU\_01\_04

Ensure that the IUT in U0, on receipt of a SETUP message (Invalid combination of traffic parameters and QOS class), sends a RELEASE COMPLETE message (Cause value = 73) and remains in U0.

**Selection:** Incoming calls with QoS class interpretation supported. PICS: MCu 2

## 5.2.2 Signalling of individual Quality of Service parameters

Test purposes for EN 301 815-1 [1] (ITU-T Recommendation Q.2965.2 [9], modified).

#### 5.2.2.1 End-to-end transit delay procedures (02)

#### OOSU 02 01

Ensure that the IUT in U0, to initiate call establishment,

sends a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters) and enters U1.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### **QOSU 02 02**

Ensure that the IUT in U3, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay present),

sends a CONNECT ACKNOWLEDGE message and enters U10.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### **QOSU 02 03**

Ensure that the IUT in U4, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay present),

sends a CONNECT ACKNOWLEDGE message and enters U10.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### **QOSU 02 04**

Ensure that the IUT in U3, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay information element absent),

sends a STATUS message (Cause value = 96, call state value = 3) and remains in U3.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### **QOSU 02 05**

Ensure that the IUT in U4, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay information element absent),

sends a STATUS message (Cause value = 96, call state value = 4) and remains in U4.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### OOSU 02 06

Ensure that the IUT in U3, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay information element with maximum end-to-end transit delay subfield present, IE instruction field flag = IE instruction field not significant),

sends a STATUS message (Cause value = 100, call state value = 3) and remains in U3.

Selection: Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### **QOSU 02 07**

Ensure that the IUT in U3, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay information element with maximum end-to-end transit delay subfield present, IE instruction field flag = follow explicit instructions, IE action indicator = clear call),

sends a RELEASE message (Cause value = 100) and enters U11.

Selection: Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### QOSU\_02\_08

Ensure that the IUT in U3, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay information element with maximum end-to-end transit delay subfield present, IE instruction field flag = follow explicit instructions, IE action indicator = discard message and report status), sends a STATUS message (Cause value = 100, call state value = 3) and remains in U3.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### QOSU\_02\_09

Ensure that the IUT in U3, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay information element with maximum end-to-end transit delay subfield present, IE instruction field flag = follow explicit instructions, IE action indicator = discard message),

sends no message and remains in U3.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### **QOSU 02 10**

Ensure that the IUT in U3, having sent a SETUP message (End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (End-to-end transit delay information element with maximum end-to-end transit delay subfield present, IE instruction field flag = follow explicit instructions, IE action indicator = discard information element, proceed and report status),

sends a STATUS message (Cause value = 100, call state value = 10) followed by a CONNECT ACKNOWLEDGE message and enters U10.

**Selection:** Outgoing calls with End-to-end transfer delay indication in SETUP messages. PICS: MCu 1

#### OOSU 02 11

Ensure that the IUT in U0, on receipt of a SETUP message (End-to-end transit delay present, requesting a QOS class/maximum end-to-end transit delay combination that can be supported),

sends any of a CALL PROCEEDING, ALERTING or CONNECT message and enters the relevant call state U9, U7 or U8.

#### QOSU\_02\_21

Ensure that the IUT in U7 or U9, having received a SETUP message (End-to-end transit delay present, requesting a QOS class/maximum end-to-end transit delay combination that can be supported), to accept the call,

sends a CONNECT message (End-to-end transit delay present, maximum end-to-end transit delay absent) and enters U10.

**Selection:** Incoming calls with End-to-end transfer delay indication in CONNECT messages. PICS: MCu 3.2

#### **QOSU 02 22**

Ensure that the IUT in U0, on receipt of a SETUP message (End-to-end transit delay present, requesting a QOS class/maximum end-to-end transit delay combination that can not be supported),

sends a RELEASE COMPLETE message (Cause value = 49) and remains in U0.

#### QOSU\_02\_23

Ensure that the IUT in U0, on receipt of a SETUP message (End-to-end transit delay present, invalid combination of transit delay, traffic parameters and QOS class),

sends a RELEASE COMPLETE message (Cause value = 73) and remains in U0.

**Selection:** T<sub>R</sub> reference point supported. PICS: R 1.2

Ensure that the IUT in U0, to initiate call establishment,

**Selection:** Outgoing calls with Extended Quality of Service parameter indication in SETUP messages.

#### OOSU 03 02

Ensure that the IUT in U3, having sent a SETUP message (Extended Quality of Service parameter, End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (Extended Quality of Service parameter present),

sends a CONNECT ACKNOWLEDGE message and enters U10.

**Selection:** Outgoing calls with Extended Quality of Service parameter indication in SETUP messages.

sends a CONNECT ACKNOWLEDGE message and enters U10.

sends a STATUS message (Cause value = 96, call state value = 3) and remains U3.

Ensure that the IUT in U4, having sent a SETUP message (Extended Quality of Service parameter, End-to-end transit delay, Quality of Service parameter, ATM traffic descriptor, Broadband bearer capability present, consistent set of parameters), on receipt of a CONNECT message (Extended Quality of Service parameter absent),

sends a STATUS message (Cause value = 96, call state value = 4) and remains U4.

**Selection:** Outgoing calls with Extended Quality of Service parameter indication in SETUP messages.

PICS: MCu 2

#### **QOSU 03 06**

Ensure that the IUT in U0, on receipt of a SETUP message (Extended Quality of Service parameter, End-to-end transit delay present, requesting a QOS class/maximum end-to-end transit delay combination that can be supported),

sends any of a CALL PROCEEDING, ALERTING or CONNECT message and enters the relevant call state U9, U7 or U8.

#### OOSU 03 07

Ensure that the IUT in U7 or U9, having received a SETUP message (Extended Quality of Service parameter, End-to-end transit delay present, requesting a QOS class/maximum end-to-end transit delay combination that can be supported), to accept the call,

sends a CONNECT message (Extended Quality of Service parameter present) and enters U10.

**Selection:** Incoming calls with Extended Quality of Service parameter indication in CONNECT messages.

PICS: MCu 4.2

#### **QOSU 03 08**

Ensure that the IUT in U0, on receipt of a SETUP message (Extended Quality of Service parameter present, requesting an unacceptable 2-point cell delay variation),

sends a RELEASE COMPLETE message (Cause value = 49) and remains in U0.

#### OOSU 03 09

Ensure that the IUT in U0, on receipt of a SETUP message (Extended Quality of Service parameter present, invalid combination of transit delay, traffic parameters and individual QOS parameters),

sends a RELEASE COMPLETE message (Cause value = 73) and remains in U0.

## 6 Compliance

An ATS which complies with this TSS&TP specification shall:

- a) consist of a set of test cases corresponding to the set or to a subset of the TPs specified in clause 5;
- b) use a TSS which is an appropriate subset of the whole of the TSS specified in clause 4;
- c) use the same naming conventions for the test groups and test cases;
- d) maintain the relationship specified in clause 5 between the test groups and TPs and the entries in the PICS proforma to be used for test case deselection;
- e) comply with ISO/IEC 9646-2 [4].

In the case of a) or b) above, a subset shall be used only where a particular Abstract Test Method (ATM) makes some TPs untestable. All testable TPs from clause 5 shall be included in a compliant ATS.

## 7 Requirements for a comprehensive testing service

As a minimum the Remote test method, as specified in ISO/IEC 9646-2 [4], shall be used by any organization claiming to provide a comprehensive testing service for network equipment claiming conformance to EN 301 815-1 [1].
