Foreword

This ETSI Technical Report (ETR) has been published by the Methods for Testing and Specification (MTS) Technical Committee of the European Telecommunications Standards Institute (ETSI). The work has been carried out jointly by the European Telecommunications Standards Institute (ETSI) and the European Workshop for Open Systems (EWOS) under the European Commission's Bon de Commande No. BC-T-019-SI.

ETSI TC-MTS and the EWOS Expert Group on Conformance Testing (EGCT) have agreed to issue a common text. The ETG version of this ETR is known as ETG 033 and was adopted by the EWOS TA 24 (1-2 March 1994).

The purpose of this ETR is to provide a guide for the harmonised European implementation of conformance test procedures in line with the ISO/IEC 9646-5 [4] OSI conformance assessment processes. This ETR supports an open test environment and acts as a bridge between the ISO/IEC 9646, Parts 1, 2, 4 and 5 [1] - [4] methodology and test tool functionality and test laboratory procedures.

ETRs are informative documents resulting from ETSI studies which are not appropriate for European Telecommunication Standard (ETS) or Interim European Telecommunication Standard (I-ETS) status. An ETR may be used to publish material which is either of an informative nature, relating to the use or the application of ETSs or I-ETSs, or which is immature and not yet suitable for formal adoption as an ETS or an I-ETS.
