### Foreword

As a result of extensions and amendments to this and other Interim European Telecommunication Standards (I-ETS) by Technical Committee Special Mobile Group (TC-SMG) it has become necessary to introduce additional parts to the concerned I-ETSs. Where additional parts to an I-ETS have been introduced the base standards are now identified by the additional wording "Part 1: Generic" in the title and the I-ETS number is followed by "-1".

Parts 2 and 3 of I-ETS 300 022 describing the DCS 1800 extension and signalling support of the second ciphering algorithm are now undergoing the ETSI Unified Approval Procedure (UAP). These I-ETSs are identified by additional wording in their titles and by their I-ETS numbers, I-ETS 300 022-2 and I-ETS 300 022-3 respectively. For the sake of conformity and alignment with the additional parts of I-ETS 300 022 this corrigendum changes the title page of I-ETS 300 022 to that shown on page 5 of this corrigendum.
