Foreword

As a result of the development of conformance tests to this and other European Telecommunication Standards (ETSS) by the Signalling Protocols and Switching (SPS) Technical Committee of the European Telecommunications Standards Institute (ETSI), it has become necessary to introduce additional parts to the concerned ETSS. Where additional parts to an ETS have been introduced, the base standards are now identified by the additional wording "Part 1: Protocol specification" in the title and the ETS number is followed by "-1".

The concerned ETSS cover the Digital Subscriber Signalling System No. one (DSS1) protocol for Integrated Services Digital Network (ISDN) supplementary services. The general structure of these ETSS is described below:

- Part 1: Protocol specification;
- Part 2: Protocol Implementation Conformance Statement (PICS) proforma;
- Part 3: Test Suite Structure and Test Purposes (TSS&TP) for the user;
- Part 4: Abstract Test Suite (ATS) and partial Protocol Implementation eXtra Information for Testing (PIXIT) proforma for the user;
- Part 5: Test Suite Structure and Test Purposes (TSS&TP) for the network;
- Part 6: Abstract Test Suite (ATS) and partial Protocol Implementation eXtra Information for Testing (PIXIT) proforma for the network;

NOTE 1: For some DSS1 standards, parts 5 and 6 are not required and are therefore omitted.

For the sake of conformity and alignment with the additional parts of ETS 300 092, this corrigendum changes the title page of Amendment 1 to ETS 300 092 to that shown on the unmarked page 5 of this corrigendum.

NOTE 2: For convenience, page 5 of this corrigendum has no page number or header, and page 6 has been left blank.
