Foreword

This amendment to ETS 300 156 (1992) has been produced by the Business TeleCommunications (BTC) Technical Committee of the European Telecommunications Standards Institute (ETSI).

This amendment contains changes to three subclauses of ETS 300 156 (1992) as detailed below:

Subclause 4.2 is amended to correct the requirements applicable to TEs supporting more than one automatic or non-automatic TEI value.

Clause 9 is amended to include direct references to subclause 4.2, and to delete the incorrect requirement to support TEI 127 with SAPI 0.

Subclause A.2.2.7 is amended to clarify that the tests of this subclause are only applicable to terminals which support the layer 2 management procedures in the circumstances required by subclause 4.2.

Amendments

Page 11, subclause 4.2, second paragraph

Replace the last sentence of the second paragraph, including the bullet points, by:

"In addition, the support of the layer 2 TEI management procedures on the broadcast data link (SAPI value 63, TEI value 127) is:

- optional for terminals supporting only TEI = 0 for the SAPs; and
- mandatory for terminals supporting one or more automatic or non-automatic TEIs in addition to TEI = 0."

Page 17, Clause 9, third paragraph

Replace the third paragraph by:

"Subclause 9.2 After the first sentence insert: This is optional for those TEs which support only TEI value 0 for all SAPs."

Page 17, Clause 9, fourth paragraph

Replace the fourth paragraph by:

"Subclause 9.3 Delete the last two sentences and include the following as a new paragraph

below. "Regarding which TEI values shall be supported, subclause 4.2 is

applicable in addition.""

Page 17, Clause 9, fifth paragraph

Insert the following between the fifth and sixth paragraph:

"Subclause 9.6.2.2 Replace the word "NOTE" by "NOTE 1".

Include the words "NOTE 2" in the comments column of table 6 in the lines where subclauses 3.3.3, 3.3.4, 3.3.4.1, 3.3.4.2 and Annex A are addressed.

Add the following to the bottom of table 6:

"NOTE 2: Regarding the support of TEI values, subclause 4.2 of ETS 300 156 (1992), modified by its Amendment 1 (1994), is applicable in addition.""

Page 27, subclause A.2.2.7

Replace complete text of by:

"Subclause A.2.2.7 of ETS 300 153 [6] applies. However, the following paragraph shall be added as the first paragraph to this subclause:

"The tests in this subclause shall only be performed where the terminal supports the layer 2 management procedures according to subclause 4.2 of ETS 300 156 (1992), modified by its Amendment 1 (1994).""
