Delete:


"This standard is the stage three standard for the ISDN 3PTY supplementary service."

Insert "req.ind" in NOTE 1 and NOTE 2, i.e.:

NOTE 1: INFORM2 req.ind is sent to the user agent with the active connection in case the held connection has been cleared first.

NOTE 2: INFORM3 req.ind is sent to the user agent with the held connection in case the active connection has been cleared first.

Page 15, amendment to subclause 7.2.2, last sentence

Insert "INFORM3", i.e.:




Figure 9.1: SDL diagrams for FE2

Page 22, amendment to subclause 8.2, figure 9.1

Delete the "parallel" output signal "INFORM1 req.ind" and update the text symbol.
