This draft amendment to ETS 300 202 (1994) has been produced by the Network Aspects (NA) Technical Committee of the European Telecommunications Standards Institute (ETSI), and is now submitted for the Unified Approval Procedure phase of the ETSI standards approval procedure.

This draft amendment contains changes to one subclause of ETS 300 202 (1994) to clarify the interaction situation for the Call Deflection (CD) supplementary service in relation to the call waiting supplementary service.

Clause 7

Insert the following text in clause 7 (i.e. before note 1):

If there is a requirement from an ISDN user not to send a call waiting notification to a calling user this requirement may not always be met, e.g. voice notification, if the calling user is outside the called user's ISDN.

Subclause 8.2

Insert 2 paragraphs in subclause 8.10.3, as follows:

Calling user:

When receiving the call waiting indication, user B can invoke the CD supplementary service.

In the case of call deflection after alerting, if the diverting user subscribes to the value "No" for the subscription option "Calling user receives notification that the call has been deflected", no notification of call waiting shall be sent to the calling user from the deflected-to user.

In case of multiple diversions, a notification of call waiting shall only be sent to the calling user if all diverting users allow notification that the call has been deflected.

A deflected call can invoke the call waiting supplementary service.
