Scope

This thirty-third part of ETS 300 356 contains the conformance test specification for ISUP version 2 basic call control and signalling procedures as specified in ETS 300 356-1 [15]. It is applicable to all types of exchanges as defined in the reference specification.

This ETS presents the requirements regarding the test method and conventions used within the Abstract Test Suite (ATS), the partial Protocol Implementation eXtra Information for Testing (PIXIT) proforma, the Protocol Conformance Test Report proforma and the ATS written in Tree and Tabular Combined Notation (TTCN)²).
