1 Scope

This draft European Telecommunication Standard (ETS) provides the test specification for the Digital Enhanced Cordless Telecommunications (DECT) authentication module defined in ETS 300 331 [1].

2 Normative references

3 Definitions and abbreviations

3.1 Definitions

For the purposes of this ETS, the following definitions apply:

The ICS can take several forms: protocol ICS, profile ICS, profile specific ICS, information object ICS, etc.

ICS proforma: A document, in the form of a questionnaire, which when completed for an implementation or system becomes an ICS.

4 Test environment

This clause specifies several requirements which shall be met, and a number of rules which shall be adhered to before testing can proceed.

4.1 Test equipment

This subclause recommends a minimum specification for each of the items of test equipment referenced in the tests.

4.1.1 PE simulator

This item of equipment shall allow T=0 protocol communications to take place on both ID-1 and plug-in DAM cards. It shall be able to generate and send any command APDU and receive any of the possible responses. These commands may be generated manually, one at a time, or automatically from a predefined batch procedure containing one or more commands.

The voltage level for Vcc (contact C1) of the DAM shall be adjustable between 0V and 6,0V to an accuracy of 0,1V. The voltage level for I/O (contact C7) when sending data to the DAM shall be adjustable between 0V and 6,0V to an accuracy of 0,1V.

The PE simulator shall be able to accept an external clock signal to drive RST (contact C3) of the DAM.

It shall be possible to access all the DAM contacts either directly or through test points.

4.1.2 Clock generation device

This item of equipment shall be able to generate a clock signal for the DAM in the range 1 MHz to 5 MHz. The voltage levels for both high and low states shall be adjustable between 0V and 6,0V to an accuracy of 0,1V. The duty cycle of the clock signal shall be adjustable between 40% and 60% to an accuracy of 1 %.

4.1.3 Precision force-inducing contacting device

This item of equipment shall be able to apply a prescribed and maintained level of force onto one or more contacts of a DAM. The range shall be between 0 and 0,5N and accurate to 0,01N.

4.1.4 Temperature controllable environment

This item of equipment shall be able to control the temperature of a chamber large enough to enclose a DAM and card reader. The range of temperature control required is between -25°C and + 85°C to an accuracy of 0.5°C.

4.1.5 Temperature measuring device

This item of equipment shall be able to measure the temperature of the DAM to within 0,5°C. The range of this device shall allow measurement of temperatures between -25°C and + 85°C.

4.1.6 Oscilloscope

This item of equipment shall be able to measure static and transient voltages on any one of the contacts of the DAM. The measurable voltage range shall be between -10 V to + 10 V (to an accuracy of 50 mV) with a timebase accuracy of 100 ns.

4.1.7 Precision measuring device

This item of equipment shall be able to measure both linear and radius of curvature dimensions to an accuracy of 0,01 mm.

4.1.8 Current measuring device

This item of equipment shall be able to measure current levels for any one of the contacts of the DAM. The measurable current range shall be between -2 mA to + 2 mA to an accuracy of 1 μ A.

4.2 IUT default conditions

Unless otherwise stated, the following is default:

- The voltage level for Vcc (contact C1) is set to 5,0V.
- The voltage levels for CLK (contact C3) are set to 0,7V and 5,0V for low and high respectively.
- The clock frequency CLK (contact C3) is set to 5 MHz with duty cycle 50 %.
- The PE simulator generated voltage levels for I/O (contact C7) are set to 0,7V and 5,0V for low and high respectively.

4.3 Default data formatting

All numeric data enclosed in single quotes (") in this document is hexadecimal data.

Where "X" is used in place of a hexadecimal digit, X ranges from "0" to "F". For example, the data '6X' ranges from '60' to '6F' inclusive.

Where data is expressed as a group of bytes, it shall be in the following format: 'XX XX XX... XX', indicating first byte, second byte, third byte etc. in that order.

4.4 Test procedure

The following statements are applicable to the test procedure subclause for all test purposes contained within this ETS:

- unless otherwise stated, all steps with the test procedure are to be carried out in order;
- where steps indicate that a PE simulator shall select a particular DF or EF using an unspecified number SELECT commands, the PE simulator is to send the correct sequence of SELECT commands in order to select the required file ID from the current file ID (this may be achieved most easily by selecting from the MF down each time);
- unless otherwise stated, the length (P3) for all READ RECORD and UPDATE RECORD commands sent by the PE simulator is to be that of the length of the EF currently selected. In the case where an EF is not currently selected, the length sent is to be 1 unless otherwise stated;
- unless otherwise stated, the offset for all READ BINARY, UPDATE BINARY and SEEK commands sent by the PE simulator is to be '00 00';
- unless otherwise stated, the length (P3) for all STATUS and GET RESPONSE commands sent by the PE simulator is to be such that all available data is read;
- unless otherwise stated, the CHV and UNBLOCK CHV presented for VERIFY CHV, CHANGE CHV, DISABLE CHV, ENABLE CHV and UNBLOCK CHV commands sent by the PE simulator is to be correct;
- unless otherwise stated, the "CHV No." (P2) for VERIFY CHV, CHANGE CHV, DISABLE CHV, ENABLE CHV and UNBLOCK CHV commands sent by the PE simulator is to be 1.

4.5 Test requirement

Where steps within a test procedure involve a PE simulator sending one or more commands to the DAM, these commands are required to be correctly executed, with the DAM responding with status conditions of '90 00' or '9F XX', unless otherwise stated in the test requirements subclause for the test.

5 Test group hierarchy

This clause contains the test group hierarchy diagrams which provide a structure for the test purposes and also a correlation between the base specification, ICS and this ETS.

The information contained in each node for each of the diagrams is as follows:

As the test group hierarchy for the DAM is large, it has been broken into subclauses to aid presentation.




Figure 1: Top level test group hierarchy




Figure 2: Breakdown of "PHY" test group




Figure 3: Breakdown of "ELEC" test group




Figure 4: Breakdown of "LOG" test group




Figure 5: Breakdown of "SEC" test group




Figure 6: Breakdown of "CMD" test group




Figure 7: Breakdown of "CEF" test group

This test applies to plug-in DAM cards.

6.1.1.2.2 Conformance requirement

- 1) Format and layout of the plug-in card shall be in accordance with ISO 7816-1,2, unless otherwise specified.
- 2) The information on the exterior of the plug-in card shall include at least the individual account identifier and the check digit.
- 3) The plug-in card shall have a width of 25 mm, a height of 15 mm, a thickness the same as an ID-1 card and a feature for orientation.

- 3) Contact C8 shall be provided (optional).

- 4) The bit/character duration and sampling time specified in ISO/IEC 7816-3, subclauses 6.1.1 and 6.1.2, are valid for all communications.
- 5) Error detection and character repetition is mandatory for the DAM for all communications.

6.3.2 Dedicated files

6.3.2.2 Conformance requirement

- 1) The identifier for and the path to DF_{DECT} shall be given in the Elementary File EF_{DIR} (optional).
- 2) The DFs for registrations shall be placed as immediate children under DF_{DECT}.
- 3) Each registration shall be placed in its own DF.

6.3.2.5 Test requirement

6.3.3 Elementary files

6.3.3.1 Definition and applicability

Elementary Files structure the way in which information is held on the DAM and provide security on how this information is accessed.

This test applies to both plug-in and ID-1 DAM cards.

6.3.3.2 Conformance requirement

- The total data length of the body of an EF with transparent structure shall be indicated in the header of the EF.
- 2) The record length of an EF with linear fixed structure shall be indicated in the header of the EF.
- 3) The record length multiplied by the number of records of an EF with linear fixed structure shall be indicated in the header of the EF.
- 4) For an EF with cyclic structure, when all the records have been used for storage, then the next storage of data shall overwrite the oldest information.
- 5) The record length of an EF with cyclic structure shall be indicated in the header of the EF.
- 6) The record length multiplied by the number of records of an EF with cyclic structure shall be indicated in the header of the EF.
- 7) The DAM shall be able to access records within a linear fixed EF using all of the methods given in subclause 6.4.2.

- b) For all EFs in the file structure on the DAM, the PE simulator sends SELECT commands to the DAM to select each EF in sequence.
- c) For all EFs successfully selected, the PE simulator sends a GET RESPONSE command to the DAM.
- d) For all transparent EFs, the PE simulator sends a READ BINARY command to the DAM. The length used shall be that of bytes 3 and 4 of the response data in step c).
- e) For all transparent EFs, the PE simulator sends a READ BINARY command with offset '00 01' to the DAM. The length used shall be that of bytes 3 and 4 of the response data in step c).
- f) For all linear fixed EFs, the PE simulator sends a READ RECORD using FIRST mode to the DAM. The length used shall be that of byte 15 of the response data in step e).
- g) For all linear fixed EFs, the PE simulator sends a READ RECORD using ABSOLUTE mode to the DAM. The record length used shall be that of byte 15 of the response data in step e) and the record number shall be that of bytes 3 and 4 of the response data in step e) divided by the record length.
- h) For all linear fixed EFs, the PE simulator sends a READ RECORD using ABSOLUTE mode to the DAM. The record length used shall be that of byte 15 of the response data in step e) and the record number shall be that of bytes 3 and 4 of the response data in step e) divided by the record length, plus 1.

6.3.3.5 Test requirement

1) After steps e) and h) the status condition returned by the DAM shall be SW1='94', SW2='02' - out of range (invalid address).

6.3.4 Methods for selecting the DECT application

6.3.4.1 Definition and applicability

In addition to the method of selecting files by file ID, the direct selection method allows selection of the DECT application, or other application on a multi-application card, using an application identifier. This test applies to both plug-in and ID-1 DAM cards.

6.3.5.2 Conformance requirement

- 1) Selection of a DF or MF shall set the current Directory on the DAM.
- 2) After a selection of a DF or MF there shall be no current EF.
- 3) After a selection of an EF, the current EF shall be set to this EF and the current Directory shall remain the DF or MF which is the parent of this EF.
- 4) The current EF shall always be the child of the current Directory.
- 5) Any application specific command shall only be operable if it is specific to the current Directory.
- 6) It shall be possible to select the following from the last selected file:
 - any file which is an immediate child of the current Directory;
 - any DF which is an immediate child of the parent of the current DF;
 - the parent of the current Directory;
 - the current DF;
 - the MF.

NOTE: Reselection of the last selected file is allowed.

7) It shall be possible to select any of the "valid selections" in table 6, subclause 6.6 of ETS 300 331 [1] for each of the "last selected file" entries.

- f) The PE simulator sends a READ BINARY command using a length of 1 byte to the DAM.

- i) The PE simulator sends a STATUS command to the DAM.
- j) Step k) is carried out for each line in Table 6, subclause 6.6 of ETS 300 331 [1].

- I) Steps m) then n) are carried out in turn.
- m) The PE simulator sends SELECT commands to the DAM to select the "last selected file".

In order to accommodate planned and possible future requirements, certain file IDs are considered reserved, and may not be used in the DAM file structure.

This test applies to both plug-in and ID-1 DAM cards.

- b) For all EFs in the file structure on the DAM, the PE simulator sends SELECT commands to the DAM to select each EF in sequence.
- c) At every DF level (including MF) within the file structure on the DAM, the PE simulator sends a SELECT command to the DAM to select the file 'FF FF'.

6.3.6.5 Test requirement

- 1) For all successful selections in step b), the ID of the selected file shall be one of those in Figure 7, clause 10 of ETS 300 331 [1] or shall not be one of those listed as reserved.
- 2) The status conditions returned by the DAM After step c) shall be SW1='94', SW2='04' file ID not found.

6.4 Security services and facilities

The tests in this subclause ensure that the IUT conforms with the security aspects which are related to the DAM.

6.4.1 Algorithms and processes

Individual testing of specific algorithms and processes within the DAM is not possible in practice due to the nature of the encapsulation and sequential use of the algorithms and processes within the DAM. However, it is possible to test all of the algorithms and processes inherently, through the testing of procedures and functions which employ these algorithms and processes. Therefore, in order to test the algorithms and processes within the DAM, the test procedures within the subclauses referenced below should be executed:

- processes B1, A11 and A12 shall be employed in the DAM after receiving a PT AUTHENTICATION command from the PE, during the authentication of a Portable Termination (PT) by the FT. Refer to subclause 6.5.17 of this ETS for an associated test procedure to inherently test processes B1, A11 and A12;
- processes B1, A21 and A22 shall be employed in the DAM after receiving an FT AUTHENTICATION command from the PE, during the authentication of a Portable Termination (PT) by the FT. Refer to subclause 6.5.18 of this ETS for the associated test procedure to inherently test processes B1, A21 and A22;
- processes B2, A11 and A12 shall be employed in the DAM after receiving a USER AUTHENTICATION command from the PE, during user authentication by the FT. Refer to subclause 6.5.19 of this ETS for an associated test procedure to inherently test processes B2, A11 and A12.

6.4.2 Authentication

The authentication mechanisms employed in the DECT system between the Fixed Termination (FT) and Portable Termination (PT) to authenticate a PT, an FT or a user, result in finite interactions with the DAM, mainly through the use of the functions PT AUTHENTICATION, ASK RANDOM, FT AUTHENTICATION and USER AUTHENTICATION. In order to test the behaviour of the DAM during these authentication mechanisms, it is sufficient to test the functions which operate on the DAM during the authentication mechanisms. The test procedures for the functions themselves shall be executed, as defined in the subclauses referenced below:

- for authentication of a Portable Termination (PT), refer to subclause 6.5.17 ("PT AUTHENTICATION function");
- for authentication of a Fixed Termination (FT), refer to subclause 6.5.18 ("FT AUTHENTICATION function");
- for user authentication, refer to subclause 6.5.19 ("USER AUTHENTICATION function");
- for mutual authentication, refer to subclause 6.5.17 ("PT AUTHENTICATION function") or subclause 6.5.19 ("USER AUTHENTICATION function") and subclause 6.5.18 ("FT AUTHENTICATION function").

6.4.3 UAK allocation

The UAK allocation mechanism, employed in the DECT system between the Fixed Termination (FT) and Portable Termination (PT), to provide initial allocation of a UAK, results in finite interactions with the DAM, mainly through the use of the functions PT AUTHENTICATION, ASK RANDOM and UAK ALLOCATION. In order to test the behaviour of the DAM during this mechanism, it will be sufficient to test the functions which operate on the DAM during the mechanism. The test procedures for the functions themselves shall be executed, as defined in the subclauses referenced below:

- for the UAK ALLOCATION function, refer to subclause 6.5.20 ("UAK ALLOCATION function");
- for the PT AUTHENTICATION function, refer to subclause 6.5.17 ("PT AUTHENTICATION function");
- for the ASK RANDOM function, refer to subclause 6.5.16 ("ASK RANDOM function").

6.4.4 File access control

6.4.4.1 Definition and applicability

Every file has its own specific access condition for each command which shall be fulfilled before the command can take place.

This test applies to both plug-in and ID-1 DAM cards.

6.4.4.2 Conformance requirement

- 1) For access condition ALWAYS, the command can be performed without any restriction;
- 2) for access condition CHV1, the command shall only be possible if one of the following three conditions is fulfilled:
 - a correct CHV1 value has already been presented to the DAM during the current session;
 - the CHV1 enabled/disabled indicator is set to "disabled":
 - UNBLOCK CHV1 has been successfully performed during the current session.
- 3) For access condition CHV2, the command shall only be possible if one of the following three conditions is fulfilled:
 - a correct CHV2 value has already been presented to the DAM during the current session;
 - the CHV2 enabled/disabled indicator is set to "disabled";
 - UNBLOCK CHV2 has been successfully performed during the current session.
- 4) For access condition FT-AUT, the command shall only be possible after a successful authentication of an FT by the DAM.
- 5) For access condition NEVER, the command shall not be possible over the DAM/PE interface.
 - NOTE 1: Allocation of ADM levels and the respective requirements for their fulfilment are the responsibility of the appropriate administrative authority.
 - NOTE 2: CR3 cannot be tested as there are no files within the DAM structure which have CHV2 as a security access policy.

Test procedure

- a) The PE simulator resets the DAM.
- b) The PE simulator sends a SELECT command to the DAM to select EF_{ICC}.
- c) The PE simulator sends a READ BINARY command to the DAM to read the first 1 byte in EF_{ICC}.
- d) The PE simulator sends an UPDATE BINARY command to the DAM to update the byte in EF_{ICC} with the byte read in step c).
- e) The PE simulator sends SELECT commands to the DAM to select DF_{DECT}.
- f) The PE simulator sends a SELECT command to the DAM to select DF_{SR1}.
- g) The PE simulator sends a SELECT command to the DAM to select EF_{IPUI}.
- h) The PE simulator sends a READ BINARY command to the DAM to read all bytes in EF_{IPUI}.
- i) The PE simulator gains CHV1 security access.
- j) The PE simulator sends a READ BINARY command to the DAM to read all bytes in EF_{IPUI}.
- k) The PE simulator sends an UPDATE BINARY command to the DAM to update all bytes in EF_{IPUI} with the actual data read in step n).
- I) The PE simulator gains FT-AUT security access.
- m) The PE simulator sends an UPDATE BINARY command to the DAM to update all bytes in EF_{IPUI} with the actual data read in step n).
- n) The PE simulator sends an INVALIDATE command to the DAM to invalidate EF_{ICC}.
- o) The PE simulator gains the security access condition(s) specified by the administrative authority for both INVALIDATE and REHABILITATE on EF_{ICC.}
- p) The PE simulator sends an INVALIDATE command to the DAM to invalidate EF_{ICC}.
- q) The PE simulator sends an REHABILITATE command to the DAM to rehabilitate EF_{ICC}.

6.4.4.5 Test requirement

After steps d), h), k) and n) the status condition returned by the DAM shall be SW1='98', SW2='04' access condition not fulfilled.

6.4.5 Subscription registration maintenance

The mechanisms employed in the DECT system between the Fixed Termination (FT), PE and DAM while entering, updating or terminating subscription registrations, results in finite interactions with the DAM through the use of functions to select, read and update EFs on the DAM, allocate an initial UAK and obtain mutual authentication. In order to test the behaviour of the DAM during the subscription registration mechanisms, it is sufficient to test the functions which operate on the DAM during these mechanisms. The test procedures for the functions themselves should be executed, as defined in subclause 6.5.

6.5 Description of the functions

The tests in this subclause ensure that the IUT conforms to the functional specification for all the commands and their respective responses.

6.5.1 SELECT function

6.5.1.1 Definition and applicability

It shall be mandatory for all cards complying with ETS 300 331 [1] to support all functions described therein.

This test applies to both plug-in and ID-1 DAM cards.

6.5.1.2 Conformance requirement

- 1) The SELECT function shall select a file according to the methods described in clause 6 of ETS 300 331 [1].
- 2) The function shall accept as an input, a file ID.
- 3) The function shall accept as an input, an application identifier (for direct selection).
- 4) If the selected file is the MF or a DF, then the function shall output the file ID, total memory space available, CHV enabled/disabled indicator and CHV status.
- 5) If the selected file is an EF, then the function shall output the file ID, access conditions, invalidation indicator, indication as to whether the file is readable even if invalidated, structure of EF and the length of the records in the case of linear fixed or cyclic structure.
- 6) If the selected file is EF_{CHV}, the function shall output all the information described for the EF, plus the number of remaining CHV attempts.
- 7) After a successful selection, the record pointer in a linear fixed file shall be undefined.
- 8) The record pointer in a cyclic file shall address the last record which has been updated or increased.

 - services n°1 to n°4.

- j) The PE simulator sends a SELECT command to the DAM to select EF_{PARK}.

- s) The PE simulator sends a SELECT command to the DAM to select EF_{DCK}.
- t) The PE simulator sends a GET RESPONSE command to the DAM.
- u) The PE simulator sends READ RECORD commands to the DAM to read the data in all the records. The record length is 8 bytes.

- v) The PE simulator sends a SELECT command to the DAM to select EF_{UAK}.
- w) The PE simulator sends a GET RESPONSE command to the DAM.
- x) The PE simulator sends READ RECORD commands to the DAM to read the data in all the records. The record length is 17 bytes.
- y) The PE simulator sends a SELECT command to the DAM to select EF_{AC}.
- z) The PE simulator sends a GET RESPONSE command to the DAM.
- aa) The PE simulator sends READ RECORD commands to the DAM to read the data in all the records. The record length is 5 bytes.
- ab) The PE simulator sends a SELECT command to the DAM to select EF_{ST}.
- ac) The PE simulator sends a GET RESPONSE command to the DAM.
- ad) The PE simulator sends a READ BINARY command to the DAM to read all available data bytes.
- ae) Steps c) to ad) are repeated for the remaining subscriptions on the DAM.

6.7.3.5 Test requirement

1) After steps f), i), l), o), r), u), x), aa) and ad) the data read shall conform to the requirements above.
