# Introduction

SMPTE ST 2094-10 [4] HDR dynamic metadata provides and describes dynamic information about the video signal. The usage of this information can be employed by the display to adapt the delivered HDR imagery to the capability of the display device. The information conveyed in the SEI or VSEI messages carrying SMPTE ST 2094-10 [4] HDR dynamic metadata is adequate for purposes corresponding to the use of Society of Motion Picture and Television Engineers SMPTE ST 2094-1 [3] and SMPTE ST 2094-10 [4].

### 1 Scope

The present document specifies the format of the SEI or VSEI messages for the carriage of SMPTE ST 2094-10 [4] HDR dynamic metadata.

The present document includes references for the carriage and signalling the presence of SMPTE ST 2094-10 [4] HDR dynamic metadata (carried in SEI messages defined in the present document) for DVB systems, as defined in ETSI TS 101 154 [i.3], ETSI TS 103 285 [9] and ETSI EN 300 468 [i.2].

### 3 Definition of terms, symbols and abbreviations

#### 3.1 Terms

For the purposes of the present document, the following terms apply:

display mapping: adapting the signal to the dynamic range and the colour gamut of the target display

dynamic range: ratio of the maximum light intensity to the minimum light intensity [i.1]

NOTE: In digital cameras the dynamic range is normally measured in terms of stops, which describe the total light range by power of 2.

extended display mapping metadata: subset of the ST2094\_data() structure

high dynamic range: typically, a dynamic range of more than 10 stops is referred to as high dynamic range

standard dynamic range: typically, a dynamic range of up to 10 stops is referred to as standard dynamic range

**Supplemental Enhancement Information (SEI) message:** carriage mechanism defined in Recommendation ITU-T H.265 [5] and in Recommendation ITU-T H.274 [11] that is intended to assist in processes related to decoding, display or other purposes

# 4 ST2094-10\_data() structure definition

### 4.1 Introduction

This clause specifies the syntax and semantics of ST2094-10\_data() structure.

Clause 4.2 defines the syntax of the ST2094-10\_data() structure.

Clause 4.3 defines the semantics of the ST2094-10\_data() structure.

The metadata elements of the ST2094-10\_data() structure are defined according to the SMPTE ST 2086 [2], SMPTE ST 2094-1 [3] and SMPTE ST 2094-10 [4].

### 4.2 ST2094-10\_data() structure syntax

The parsing process of each syntax element by the descriptor u(n) is described in Recommendation ITU-T H.265 [5] for HEVC and VSEI [11] for VVC.

#### 4.3 ST2094-10\_data() structure semantics

**app\_identifier** identifies an application and shall be set equal to 1 according to constraints of the section 5 of SMPTE ST 2094-10 [4].

**app\_version** specifies the application version in the application and shall be set equal to 0 according to constraints of the section 5 of SMPTE ST 2094-10 [4].

**metadata\_refresh\_flag** when set equal to 1 cancels the persistence of any previous extended display mapping metadata in output order and indicates that extended display mapping metadata follows. The extended display mapping metadata persists from the coded picture to which the SEI message containing ST2094-10\_data() is associated (inclusive) to the coded picture to which the next SEI message containing ST2094-10\_data() and with **metadata\_refresh\_flag** set equal to 1 in output order is associated (exclusive) or (otherwise) to the last picture in the CVS (inclusive). When set equal to 0 this flag indicates that the extended display mapping metadata does not follow.

**num\_ext\_blocks** specifies the number of extended display mapping metadata blocks. The value shall be in the range of 1 to 254, inclusive.

dm\_alignment\_zero\_bit shall be equal to 0.

**ext\_block\_length**[ i ] is used to derive the size of the i-th extended display mapping metadata block payload in bytes. The value shall be in the range of 0 to 1 023, inclusive.

**ext\_block\_level**[i] specifies the level of payload contained in the i-th extended display mapping metadata block. The value shall be in the range of 0 to 255, inclusive. The corresponding extended display mapping metadata block types are defined in Table 4. Values of ext\_block\_level[i] that are reserved shall not be present in the bitstreams conforming to this version of the present document. Blocks using reserved values shall be ignored:

- When the value of ext\_block\_level[ i ] is set equal to 1, the value of ext\_block\_length[ i ] shall be set equal to 5.
- When the value of ext\_block\_level[ i ] is set equal to 2, the value of ext\_block\_length[ i ] shall be set equal to 11.
- When the value of ext\_block\_level[ i ] is set equal to 3, the value of ext\_block\_length[ i ] shall be set equal to 5.
- When the value of ext\_block\_level[ i ] is set equal to 4, the value of ext\_block\_length[ i ] shall be set equal to 3.
- When the value of ext\_block\_level[ i ] is set equal to 5, the value of ext\_block\_length[ i ] shall be set equal to 7.

When an extended display mapping metadata block with ext\_block\_level equal to 5 is present, the following constraints shall apply:

- An extended display mapping metadata block with ext\_block\_level equal to 5 shall be preceded by at least one extended display mapping metadata block with ext\_block\_level equal to 1, 2, 3 or 4.
- Between any two extended display mapping metadata blocks with ext\_block\_level equal to 5, there shall be at least one extended display mapping metadata block with ext\_block\_level equal to 1, 2, 3 or 4.
- No extended display mapping metadata block with ext\_block\_level equal to 1, 2, 3 or 4 shall be present after the last extended display mapping metadata block with ext\_block\_level equal to 5.
- The metadata of an extended display mapping metadata block with ext\_block\_level equal to 1, 2, 3 or 4 shall be applied to the active area specified by the first extended display mapping metadata block with ext\_block\_level equal to 5 following this block.
- When the active area defined by the current extended display mapping metadata block with ext\_block\_level equal to 5 overlaps with the active area defined by preceding extended display mapping metadata blocks with ext\_block\_level equal to 5, all metadata of the extended display mapping metadata blocks with ext\_block\_level equal to 1, 2, 3 or 4 associated with the current extended display mapping metadata block with ext\_block\_level equal to 5 shall be applied to the pixel values of the overlapping area.

**min\_PQ** specifies the minimum luminance value of the current picture in 12-bit PQ encoding. The value shall be in the range of 0 to 4 095, inclusive. Note that the 12-bit min\_PQ value with full range is calculated as follows:

$$\min_{PQ} = \text{Clip3}(0, 4\ 095, \text{Round}(\text{Min} \times 4\ 095)) \tag{1}$$

where Min is MinimumPqencodedMaxrgb as defined in clause 6.1.3 of SMPTE ST 2094-10 [4].

**max\_PQ** specifies the maximum luminance value of current picture in 12-bit PQ encoding. The value shall be in the range of 0 to 4 095, inclusive. Note that the 12-bit max\_PQ value with full range is calculated as follows:

$$\max_{PQ} = Clip3(0, 4\ 095, Round(Max \times 4\ 095))$$

where Max is MaximumPqencodedMaxrgb as defined in clause 6.1.5 of SMPTE ST 2094-10 [4].

**avg\_PQ** specifies the midpoint luminance value of current picture in 12-bit PQ encoding. The value shall be in the range of 0 to 4 095, inclusive. Note that the 12-bit avg\_PQ value with full range is calculated as follows:

$$avg_PQ = Clip3(0, 4\,095, Round(Avg \times 4\,095))$$

where Avg is AveragePqencodedMaxrgb as defined in section 6.1.4 of SMPTE ST 2094-10 [4].

**target\_max\_PQ** specifies the maximum luminance value of a target display in 12-bit PQ encoding. The value shall be in the range of 0 to 4 095, inclusive. The target\_max\_PQ is the PQ encoded value of TargetedSystemDisplayMaximumLuminance as defined in clause 10.4 of SMPTE ST 2094-1 [3].

If there is more than one extended display mapping metadata block with ext\_block\_level equal to 2, those blocks shall have no duplicated target\_max\_PQ.

**trim\_slope** specifies the slope metadata. The value shall be in the range of 0 to 4 095, inclusive. If trim\_slope is not present, it shall be inferred to be 2 048. Note that the 12-bit slope value is calculated as follows:

$$trim\_slope = Clip3(0, 4\ 095, Round((S - 0,5) \times 4\ 096))$$

where S is the ToneMappingGain as defined in clause 6.2.3 of SMPTE ST 2094-10 [4].

**trim\_offset** specifies the offset metadata. The value shall be in the range of 0 to 4 095, inclusive. If trim\_offset is not present, it shall be inferred to be 2 048. Note that the 12-bit offset value is calculated as follows:

$$trim_offset = Clip3(0, 4\ 095, Round((0+0,5) \times 4\ 096))$$

where O is the ToneMappingOffset as defined in clause 6.2.2 of SMPTE ST 2094-10 [4].

**trim\_power** specifies the power metadata. The value shall be in the range of 0 to 4 095, inclusive. If trim\_power is not present, it shall be inferred to be 2 048. Note that the 12-bit power value is calculated as follows:

$$trim_power = \text{Clip}3(0, 4\ 095, \text{Round}((P - 0.5) \times 4\ 096))$$

where P is the ToneMappingGamma as defined in clause 6.2.4 of SMPTE ST 2094-10 [4].

**trim\_chroma\_weight** specifies the chroma weight metadata. The value shall be in the range of 0 to 4 095, inclusive. If trim\_chroma\_weight is not present, it shall be inferred to be 2 048. Note that the 12-bit chroma weight value is calculated as follows:

where CW is the ChromaCompensationWeight as defined in clause 6.3.1 of SMPTE ST 2094-10 [4].

**trim\_saturation\_gain** specifies the saturation gain metadata. The value shall be in the range of 0 to 4 095, inclusive. If trim\_saturation\_gain is not present, it shall be inferred to be 2 048. Note that the 12-bit saturation gain value is calculated as follows:

$$trim\_saturation\_gain = Clip3(0, 4\,095, Round((SG + 0,5) \times 4\,096))$$

where SG is the SaturationGain as defined in clause 6.3.2 of SMPTE ST 2094-10 [4].

ms\_weight this field is reserved for future specification. This 13-bit signed integer shall be 0x1fff (-1).

The 12-bit avg\_PQ\_offset value is calculated as follows:

active\_area\_left\_offset, active\_area\_right\_offset, active\_area\_top\_offset, active\_area\_bottom\_offset represent the coordinates of UpperLeftCorner and LowerRightCorner constrained in clause 7.1 of SMPTE ST 2094-10 [4] as follows:

UpperLeftCorner = (active\_area\_left\_offset, active\_area\_top\_offset) LowerRightCorner = (XSize - 1 - active\_area\_right\_offset, YSize - 1 - active\_area\_bottom\_offset) (18)
