

The present document is part of a TS-family, which describes the requirements and information model necessary for Telecommunications Management (TM). The TM principles and TM architecture are specified in 3GPP TS 32.101 [1] and 3GPP TS 32.102 [2].

A standard general-purpose mechanism for the management of logs containing selected notifications from the network is required to provide an ability to perform historical analysis on faults and conditions, which occurred in the network. The TS 32.33x-series, constituting the Notification Log IRP, sets forth such a mechanism - and the present document contains the XML definition related to Notification IRP notification header.

1 Scope

The present document specifies the XML Definitions for the Notification Integration Reference Point (Notification IRP) as it applies to Itf-N, in accordance with Notification IRP IS definitions [3].

This XML Definitions specification defines the Notification IRP XML Notification header format.

This specification is related to 3GPP TS 32.302.

4.1 Notification IRP XML notification header Definitions

This clause provides XML definitions of Notification IRP notification header as defined in 3GPP TS 32.302 [3]. These definitions are to be used in conjunction with Notification Log IRP XML Definitions for Notification Log IRP XML Data File and the NL IRP XML Notification Format (3GPP TS 32.335 [4]).




Figure 4.1: Structure of the Notification IRP XML Notification header Format

The structure of the Notification IRP XML Notification header Format is shown in figure 4.1.
