4.4.4 Robustness and fuzz testing

The test cases under clause 4.4.4 of TS 33.117 [2] are applicable to PCF.

According to clause 4.4.4 of TS 33.117 [2], the transport protocols available on the interfaces providing IP-based protocols need to be robustness tested. The interface defined for the PCF in clause 4.2.3 of TS 23.501 [3] is Npcf.

Following TCP/IP layer model and considering all the protocols over transport layer, for PCF, the following interface and protocols are under testing:

- For Npcf: The TCP, HTTP2 and JSON protocols.

NOTE: There could be other interfaces and/or protocols requiring testing under clause 4.4.4 of TS 33.117 [2].
